Testimony of Rep. Maureen Terry in support of LD 1619, An Act to Improve Maine's Reproductive Privacy Laws Before the Joint Standing Committee on Judiciary

Senator Carney, Representative Moonen and esteemed members of the Judiciary Committee, I am Maureen Terry, representing part of Gorham in House District 108. I am here today to speak in strong support of LD 1619, An Act to Improve Maine's Reproductive Privacy Laws.

As a mother of three daughters, I know firsthand the importance of access to proper medical care. It is essential that we trust medical professionals who have committed to uphold ethical standards outlined in the Hippocratic Oath, including to care for the sick and to do no harm. With all due respect, they are the experts, not me and not you. They have dedicated their lives to helping others and should be allowed to make decisions with their patients without interference from politicians.

This is why I am in favor of LD 1619, which would waive the current viability standard for abortions deemed medically necessary but that are currently prohibited. This bill would help ensure that women have access to the care they need when they need it when making an extremely difficult decision to end a later-term pregnancy.

Current Maine law restricts access to abortions after viability, even if it is deemed medically necessary. This means that individuals are forced to carry a pregnancy to term, regardless of the risks to their own health or the health of the fetus.

That is not only unfair, but it is dangerous. Women should not be forced to put their lives at risk because of outdated laws that do not take into account modern medical advancements. Medical

professionals should be allowed to make decisions based on their expertise and the individual needs of their patients.

I want my daughters to have access to the best medical care possible. I want them to know that they can trust their doctors and that they will be able to get the care they need when they need it in their communities and surrounded by family and loved ones. Passing this bill will not change the number of abortions that occur later in pregnancy, but it will mean that women won't have to drive hours out of state, leaving behind their support networks and possibly having to spend thousands of dollars just to access necessary medical care.

This bill would help ensure that my daughters and all people who might need an abortion have access to the care they need, without fear of political interference. It would allow medical professionals to do their jobs without the burden of restrictive laws that do not take into account the complexities of individual medical cases.

I urge you to support this bill. It is time for us to trust medical professionals and ensure that women have access to the care they need when they need it. This should not be a political issue; it is a matter of basic human rights and access to appropriate medical care.
