Members of legislation, my name is Miriam Jacobs, I live in Canaan, and I am the Child & Family Services Family Engagement Manager at Kennebec Valley Community Action Program (KVCAP). In my role, I oversee the Family Services Content including the Whole Family Coaching and Approach within the Agency.

I support LD 1995 because we all benefit when families have access to high quality Family Support services that include a multi-generational approach as well as a focus on the Whole Family. Supporting a family to create individualized goals that focus on work and/or education allow a family to begin envisioning themselves and their families in a more stable financial situation. When families have the support of a Family Coach, barrier funds for emergency needs, holistic family support, access to resources and referrals, and increased community connections, families can continue to take necessary steps to achieve their goals.

With recent funding from TANF and MeCAP, KVCAP began offering these supports to families within Somerset and Kennebec Counties. Initially planning to start small, the option was highly received and services were provided as well as a growing waiting list. It was quickly realized that providing this type of support to families was meeting a community need. We also learned that in order to support families there had to be an ongoing effort to meet families where they were and to partner with families as they met the many stressors and challenges of everyday life. This included referrals to mental health services, referrals to basic needs such as food and housing, Child Protective involvement, substance use supports and services, as well as many other crisis interventions. Staff need to be skilled and caseloads need to be appropriate to meet the needs of the enrolled families.

Increased funding would allow KVCAP to expand services and serve more families. It will assist in funding increased training, compensation, and lower caseloads for family coaches. KVCAP has seen many families set and reach goals, and to then create new goals that continue to move them forward on their life journey that improves the living situation for them and their families. Allow me to share one family's story.

"As new Mainers, a family partnered with a whole family coach for several years to turn challenges to opportunities and aspirations into successes. At the beginning of their journey together, this small family had a lot of drive, but was struggling month to month to meet basic expenses while trying hard to hold onto their dreams.
