Comparisons between British Columbia, Portugal, and Oregon with allowable drug possession amounts that <u>would not</u> be criminal offenses

British Columbia drug possession exemptions:

- Opioids (heroin, morphine, fentanyl)
- Cocaine
- Methamphetamine
- Ecstasy

What remains illegal: A combined total of <u>more than 2.5 grams</u> of exempted drugs or any amount of other illegal drugs not included in exemption

Portugal

Threshold for non-criminal offense (considered 10 days' average consumption)

Cannabis: Resin 5g; herbal 25g; THC 5g; Oil 2.5g

Ecstasy: 1 gHeroin: 1 gCocaine: 2 g

Anything above threshold is considered supply and a criminal offense

*It is important to note that Portugal has socialized medicine, and doesn't not have the level of illicit drug market that US has, has not experienced the proliferation of fentanyl, and historically marijuana has been the most widely abused drug.

Oregon:

Possession of the following amounts of drugs <u>is criminal (misdemeanor)</u> if exceeds these amounts:

Heroin: 1 g

• MDMA: 1 g or 5 pills

• Cocaine: 2 g

• Methamphetamine: 2 g

LSD: 40 units
Psilocybin: 12 g
Methadone: 40 g
Oxycodone: 40 pills

Fentanyl: 1 g or 5 or more user units

Felony amounts:

Heroin: 5 g

• Ecstasy: 5 g or 25 pills

Cocaine: 10 g

Methamphetamine: 10 g

LSD: 200 unitsPsilocybin: 60 g

• Fentanyl: 5 g or 25 or more user units

Anything <u>under threshold for misdemeanor amounts is a civil infraction</u> with a \$45 minimum fine and a \$100 maximum fine, no other possible penalties. If individual completes a treatment screening within 45 days of citation, case is dismissed. Currently failure to complete screenings or pay fines have had no consequence.
