I wrote my rep and senator before and after the LD1619 vote, but apparently I never said the right words.to enlighten them to vote against it, like any human being would do, if only they knew exactly what abortion entails. I see now that I must elaborate, in more specific terms.

LD 780 is designed to enshrine into our Maine Constitution the right to dismember a live, feeling, fully-formed unborn baby up until birth, or about 38 weeks gestation. Between the 18th and 20th week, the unborn baby has developed a complete and working nervous system, and can feel pain with his or her brand-new nerves and sensors even more acutely than you or I would. They only develop the sensors that let them go unconscious after the 28th week. There is never an anesthesia administered to the baby. And by "dismember," what no one really wants to say is, to cut, tear, twist and pull apart each arm and leg, one by one (their tendons and ligaments are very, very strong at this point), and then crush his or her skull.

I imagine many of you are parents, and I think many of you have never been enlightened as to what an abortion really is, so I hope what I'm saying resonates with you. And what I'm saying is easily verifiable from any medical, scientific, or biological resource, except, of course, from Planned Parenthood, who has held the sex-ed contract in Maine schools for over 40 years now.

So how will you respond to your kids who, these days, rely on proven facts instead of Planned Parenthood propaganda, when they find out that you voted for this horrific torture of a live baby? Or worse yet, what if your kids agree with you, and wind up subjecting your yet-to-be-born/yet-to-be-aborted grandchildren to this Constitutionally-legalized barbaric excruciating pain, because of your vote?

I have hope for you; otherwise I wouldn't waste my time writing this, and your time reading/hearing this. Sorry for the blunt wording, but I honestly want you on our side, the side of the unborn. This is not political; this is humane common sense.
