Senator Lawrence, Representative Ziegler and the esteemed members of the Energy, Utilities and Technology Committee: My name is *Megan Sauberlich*, I am a resident of Falmouth, and a *student activist* with Maine Youth Action. I am [speaking] in support of LD 2077, An Act Regarding Customer Costs and Environmental and Health Effects of Natural Gas.

The numbers of deaths, illnesses, and worsening climate catastrophes are not just reports to scan over and decide whether they are worthy of attention. Talking Points:

- LD 2077 is a bill to protect Mainers. This Act is an opportunity to address the health, financial and environmental issues resulting from gas utilities' pollution of residential and commercial buildings.
- The World Health Organization has reported on numerous health disorders (acute and chronic respiratory diseases, tuberculosis, asthma, cardiovascular disease and prenatal health outcomes) caused by indoor gas utilities. (WHO, 2007). <u>Health impacts of indoor air pollution from household solid fuel on children and women ScienceDirect</u> Gas stoves produce higher levels of nitrogen oxide—a toxic gas—which may worsen existing respiratory problems and

cause learning and memory deficits. Studies also reveal children are especially susceptible to the effects of indoor pollution.

The industry's response has been to pitch fossil gas alternatives ("FGAs"), including biomethane and hydrogen. However, these alternative fuels face major cost and supply limitations, and raise environmental justice and emissions concerns.

- In fact, Hydrogen-based, low-temperature heating systems consume 500% to 600% more renewable energy than heat pumps.
- People spend about 90% of their time indoors. In this time, significant amounts of natural gas are emitted as unburned methane, a greenhouse gas, with an estimated 75 percent of the emissions occurring when household appliances are shut off. This bill will take action on health standards for residential and commercial areas that should not be ignored.
- Maine will also benefit from the financial implications of phasing out natural gas. California eliminated subsidies for developers to connect new properties to the gas system in July 2023, a move that will save gas customers an estimated \$160 million per year.
- <u>Net Zero America</u> study by researchers at Princeton University produced several forecasts on improvements in air quality, showing cumulative action to phase out natural gas saves more than 42,000 lives annually. When we have safer and even more affordable alternatives to transform our, and future generations health, these options should be researched and implemented as much as needed to create a safer environment for Maine citizens.
- The goal to cut emissions significantly by 2050 is being prioritized by many states. The transition to cheaper, less pollutive infrastructure, marks the future of a new energy system. In addition to California, Illinois, Colorado and Washington have taken legislative incentives to implement cleaner energy standards, planning for the future of electrification. This transformation renders virtually all new pipeline investments useless decades before their 80+ year expected lifetimes.
- By addressing numerous health and climate concerns, LD 2077, will cover the social and climate costs gas utility companies have ignored for too long and allow Maine to prepare for the evolving energy system
