

The testimony below was submitted in 2022 in support of LD-1999, and is now resubmitted in support of LD-2210 An Act to Establish a Civil Rights Unit and a Civil Rights Review Panel Within the Office of the Attorney General and Require Ongoing Enhanced Civil Rights Training for Civil Rights Officers.

My name is Nathan Kempthorne, and I am submitting the following testimony in support of *LD-1999 An Act To Require Civil Rights Officers at Law Enforcement Agencies*.

My family experienced extreme racial discrimination in Maine, and ultimately left the state for our safety. I believe this bill is an important step toward creating an intake pathway for civil rights complaints to be submitted at the local level. I also submit that the civil rights officers should be vocal about their role in the community, and there should be public outreach to marginalized communities throughout the state to make sure they understand their rights and how to submit a complaint.

I am submitting multiple internal emails (collected via FOAA) from the office of the Attorney General that demonstrate the Washington County Sheriff's Office and the Machias Police Department did not have trained civil rights officers on staff when my family would have needed them. Additionally, the OAG emails indicate this was "essentially a violation of state law," and infers this is an issue throughout the state.

It should be noted that since 2019 ensuring law enforcement agencies have trained civil rights officers has been the responsibility of chief law enforcement officer, Attorney General Aaron Frey, and for the prior eleven years the former Attorney General Janet Mills.

For 21 years - since 2001 – this has also been the direct responsibility of the current Chief of Financial Crimes and Civil Rights, AAG Leanne Robbin. https://www.maine.gov/ag/about/division_chief_bios.shtml?id=95215 She has failed miserably, and the civil rights of marginalized people in the state of Maine have never been safe under her watch. She has made every effort to do the bare minimum, and the statistics demonstrate the effect.

Please note that these emails are the position of the Office of the Attorney General and are riddled with self-serving inaccuracies meant to defend their inaction:

- The date the AG became aware of the complaint was days earlier.
- The AG's office did not investigate anything (see emails below).
- The AG's office noted my family's reasons for not reporting to the local police, Washington County Sheriff's office and the District Attorney's office due to concerns of racial bias and did nothing.
- The AG's office never took our complaint seriously, and internal emails demonstrate the Chief of Civil Rights AAG openly mocking my family to her detective, and the Attorney General forgetting multiple times to respond for months even though he was routinely asked for a response by both my family and formally by a delegation of Washington County legislators.
- The OAG refused to help us because we didn't file a complaint with a non-existent entity.
- The one fact AG Aaron Frey did get correct was that it was over 159 days from the time a complaint was submitted to his office to the date anyone in the Maine State law enforcement community (AAG Leanne Robbin and Detective Marge Berkovich) ever asked my wife a direct question about what happened to her.
- At no point did Attorney General Frey or Civil Rights AAG Leanne Robbin direct my family to report to a trained civil rights officer or to local or state law enforcement, nor did they refer our case to law enforcement for action.
- Following that Zoom call, Civil Rights AAG Leanne Robbin then went on to continue to mock us to her staff in official emails, belittle our losses and demonstrate a complete bias for the school.

I submit Maine not only needs this law, it needs a new team with empathy implement this important legislation.

I will let the AG's office and the legislator's words below stand on their own, and strongly urge that this bill OUGHT TO PASS, and that follow-on legislation should ensure enforcement of this law.

Attorney General Frey/Commissioner Makin:

The Washington County Legislative Delegation is writing today to request a formal investigation into allegations of racism and bullying at Washington Academy in East Machias made by one of our constituents, Mr. Nathan Kempthorne.

We believe the claims made by Mr. Kempthorne are horrifying, unacceptable and must be fully and openly investigated by your offices along with the Maine Human Rights Commission to allow our community, the school, students, and their families to move forward. We believe it is critical those who have experienced racial discrimination have an opportunity to be heard and given the opportunity to air their grievances without fear of repercussion. The severity and nature of these allegations must be fully explored in the name of justice and equality under the law.

Racism, abuse, and bullying have no place in our society, much less our K-12 educational system; not in Maine; not in Washington County; nor in Washington Academy. Such behavior is unacceptable and must be investigated and prosecuted to the fullest extent of the law if we are going to turn a corner – especially where minors are involved.

We also have faith in your offices to conduct a fair, open, and thorough investigation working with the Human Rights Commission, students, staff, and families affected by these alarming and disturbing allegations. While it is not customary for legislators to ask for such action, we want to reiterate again that even the suggestion of this kind of behavior is disgusting and unacceptable. We have no other alternative but to get to the bottom of it.



Attorney General Frey:

The undersigned members of the Washington County Legislative Delegation are writing to ask you for a formal update on your findings into allegations of racism at Washington Academy in East Machias. We believe these allegations are grave and that your office should formally detail to us, and those making them, your findings along with any recommendations you may have to ensure the civil rights of students, staff, and faculty at Washington Academy.

As you know, we formally requested an investigation into these matters last August. In October, your office informed us that findings and recommendations would be forthcoming within a matter of weeks.

We are troubled that no such report has been issued and no such recommendations have been made. We are also deeply concerned that an investigation has not taken place, or that the results of such an investigation have not been fully conveyed to those making the allegations.

We would ask you to do so in a timely manner so that all parties involved can move forward and begin the process of taking appropriate next steps, as we know you take allegations of civil rights violations and racist behavior very seriously.

Re: Washington Academy

Dear Senator Moore and Representatives Tuell, Alley, Perry, and Newell:

I am writing to provide you with information regarding my office's response to allegations of racial discrimination, harassment and bullying at Washington Academy ("WA") in East Machias.

I first learned of potential issues at WA on August 5, 2020, when I received correspondence from Nathan Kempthorne. Mr. Kempthorne's older daughter graduated from WA in 2018, and his younger daughter was, at the time, a senior at WA. Mr. Kempthorne's wife, Esther, is a naturalized citizen who emigrated from Mexico and was, at the time, a Spanish teacher at WA.

Mr. Kempthorne alleged various disturbing incidents of racist and anti-immigrant conduct at WA. He stated that minority students were subjected to racial slurs and discrimination. He described taunting of individuals participating in a Black Lives Matter demonstration. Mr. Kempthorne stated that his younger daughter had been bullied and harassed online for having supported the Black Lives Matter movement and that his older daughter had been the subject of racist taunts and slurs. He described an incident in March 2020 in which Ms. Kempthorne found a noose in her classroom. Ms. Kempthorne did not immediately report this incident because she was not aware of the possible significance of the noose until June 20, 2020, when a noose was reported in Deer Isle. Mr. Kempthorne alleged that the WA administration was failing to properly address what he viewed as systemic racism at WA. He also alleged that the administration at WA had blocked establishment of a student-run Civil Right Team.¹ Mr. Kempthorne asked me to look into his allegations. You – the Washington County delegation – asked me to do the same.

The day after receiving Mr. Kempthorne's letter, the Director of our Civil Rights Team Project, Brandon Baldwin, contacted Mr. Kempthorne directly regarding the lack of a Civil Rights Team at WA. Subsequently, Mr. Baldwin reached out to members of the WA community

¹ Mr. Kempthorne also stated that in 227 years, only one student of color graduated as valedictorian and that of the more than 80 WA staff members, only two were persons of color.

Justice Academy. To our knowledge, the Machias Police Department still lacks a civil rights officer, although the agency has had such officers in the past.

Mr. Kempthorne's allegations of racial bias and harassment at WA are certainly concerning. In the absence of conduct constituting a violation of the MCRA, though, my office has limited authority. As noted above, while we explored bringing a MCRA action here, we ultimately concluded that the available evidence would not support it. Another tool we have is to promote the creation of Civil Rights Teams at schools, and we have found that these Teams are very successful in promoting tolerance and curbing bias-based harassment, bullying, and discrimination. We are hopeful that WA's newly established Civil Rights Team will achieve similar success.

Finally, you should be aware that there are other governmental entities that may be able to investigate and address allegations of bias-based conduct. Complaints may be filed with the Maine Human Rights Act (<http://www.maine.gov/mhrc/home>) or with the United States Department of Education's Office for Civil Rights (<https://www2.ed.gov/about/offices/list/ocr/index.html>).

[Thank you for bringing the issues to our attention. The efforts of the Kempthorne family have resulted in an internal review by the school, the creation of a civil rights team, the designation of a civil rights officer at the Sheriff's Office and increased community awareness of the harms caused by racist speech. These are important steps to ensuring that all students feel safe at school, regardless of their race or ethnicity. My office remains committed to promoting education of civil rights issues through the Civil Rights Teams Project and to protecting all Maine citizens through our enforcement of the Maine Civil Rights Act. On January 11, 2021, Assistant Attorney General Leanne Robbin and Detective Margie Berkovich met with Esther and Nathan Kempthorne on zoom. Leanne and Margie are assigned to the enforcement of the Maine Civil Rights Act, which authorizes my office to bring a civil action to enjoin the use or threat of physical force or violence against a person motivated by bias against the person's race, color, religion, sex, ancestry, national origin, physical or mental disability or sexual orientation. Prior to their meeting, Leanne and Margie had reviewed all the correspondence from the Kempthorne family and had concluded that the only possible actionable conduct under the statute was the alleged display of a noose in Esther's classroom. Esther indicated that she saw the noose in the first week of March 2020, but she had not realized its significance until June 2020, when the press reported about the display of a noose in Deer Isle. Esther described the noose as two inches long and located on the end of the string that operated the old blinds on her classroom window. She reported that the noose had not been there when she opened the blinds in the morning but was present when she closed them at the end of the day. She did not know who might have looped the string into a noose shape or whether that person intended the shape to be a threat, because students had been in and out of the classroom all day. Leanne and Margie concluded that they would not be able to gather evidence to identify who tied the string or to determine whether it was intended as a threat based on Esther's national origin.

At the time of the meeting, neither of the local law enforcement agencies with jurisdiction over Washington Academy had dedicated civil rights officers on their staffs trained to identify and refer cases to our office under the Civil Rights Act. Since the meeting, the Washington County Sheriff's Office has assigned a civil rights officer who has now completed the civil rights training at the Maine Criminal Justice Academy. To our knowledge, the Machias Police Department still lacks a civil rights officer, although the agency has had such officers in the past.

By the time of the zoom meeting, Washington Academy had established a student civil rights team under the Attorney General's Civil Rights Teams Project. The mission of the team is to increase the safety of all students by reducing bias-motivated behaviors and harassment.

Note: In this email Civil Rights AAG Leanne Robbin admits her office could have called the local and state law enforcement agencies to “prod or back up” their efforts, but she never did in our case. As a matter of fact, she never actually recommended we report anything to law enforcement, even in our Zoom meeting 159 later.

Note: In the below email the current Attorney General victim blames a Latinx immigrant and MDOE certified educator for not reporting to law enforcement for the case going stale. We had alerted a Maine state law enforcement officer and a local police officer in June (months earlier), and the Attorney General's office on August 1, 2020.

A civil rights officer would have been a wonderful relief for us at this juncture, but the AG only appears to be looking to shed responsibility for his office's inaction. At no point in over 159 days (or since) do we have any evidence AG Frey or AAG Robbin contacted the District Attorney, the Washington County Sheriff's office or the Machias Police Department on our behalf.

We have received numerous emails from the Kempthornes that cover a range of allegations. I spoke at length with an attorney for Mrs. Kempthorne and her daughter about the concerns of the Kempthornes. (Attorney Shelby Leighton) I have spoken with members of the Legislature (Moore, Millet, Kornfield) and with at least one commissioner (Makin) about these allegations. We have had several folks in the office spend time considering these allegations (Susan, Brian, Leanne, Sarah, Brandon). Marc engaged with Congressman Golden's Office, too. The Civil Right Team Project has worked directly with Washington Academy to establish a Civil Rights Team Unit. Leanne did reach out this weekend to speak with the Kempthornes – This was always the plan and I had discussed this with Attorney Leighton, but originally, I was going to have something in writing released first. In light of the allegation in Kempthorne's weekend email that we were ignoring him, that plan changed and Leanne and I discussed her reaching out immediately. It is my intent to issue a letter that 1) summarizes the extent of this consideration and 2) concludes that there is an absence of evidence to support any legal role for the OAG. (Maybe Leanne will learn something in her phone call that affects this – I was disappointed by what little Attorney Leighton could offer me when I spoke with her because I thought, as an attorney, she would have gathered relevant information)

The Kempthorne's had refused to engage with the appropriate law enforcement agencies (Washington County Sheriff's Department and Washington County District Attorney's Office) and that resulted in the case growing stale before we were even contacted (incident allegedly occurred in March, Mrs. Kempthorne learned of its meaning in June, OAG was contacted in early August).

This is all just background to try to get everyone on the same page. Probably not much to tell Bill at this point.

Probably fine to confirm that Leanne did reach out to the Kempthorne's to engage them directly, which has been the plan for some time.

Good morning,

It's almost November. My wife, daughter and I have been trying to address racism they experienced in Washington Academy for almost six months. While we waited for someone to do something, we ran out of money and available credit cards for an attorney and can no longer afford legal representation. Since we are now completely on our own I want to address some questions I have been asked by several of you regarding the process we took in reporting the racism my family experienced.

Question: Why didn't you file a police report with the Sheriff's department?

We reported our concerns directly to the Attorney General's office because the Washington County Sheriff supports an openly bigoted candidate for the 2nd District and we don't trust him anymore. This is sad because he is one of the very few Republicans I have ever voted for in my life. Here is a picture of the Washington County Sheriff with his hand on the shoulder of Dale Crafts. The police in Washington County also overwhelmingly supported Paul LePage as Governor, who referred to Latinx people as "the enemy" and now proudly stand with Donald Trump who called Mexicans "rapists and killers." Why would we ever file a report with them?

Question: Why didn't you file a Maine Human Rights Complaint?

Answer: The Maine Human Rights Commission is part of the problem. When we initially looked into this option we immediately noticed the Chair was appointed by an openly anti-Latinx, very racist Governor LePage, and one can only assume it is because they share the same values. We then noticed if my wife or daughter filed a complaint it would be to a commission chaired by a man who sits on the Board of Visitors at UMaine Machias with the Headmaster of Washington Academy, and whose business partner is a long-time Washington Academy Board of Trustees Member and former Board President of her school.

Additionally the MHRC which is famously not diverse is not set up to quickly triage and support victims - it is a process that at times can take years to complete with no assurances survivors will see justice. That process which will only extend my family's trauma, and ensures most people who suffer and makes sure the majority will not engage the MHRC. The MHRC is set up as bureaucratic mountain that Mainers suffering discrimination must climb, sometimes for years, before possibly seeing any resolution and I refuse to put my daughter through any more suffering.

As of February 2024, the Assistant Attorney General who wrote the emails below remains in a leadership position at the Office of the Attorney General as the Financial Crimes Division Chief, and is the AAG that to whom delegates civil rights cases.

Note: I am submitting these internal emails as evidence (these are just a few of many) that the implementation of LD-1999 should include not only a new Attorney General, but a new Civil Rights Assistant Attorney General to implement these important changes.

The emails were reported to the legislature last summer, including Senator Craig Hickman and Representative Rebecca Millett who met with Attorney General Aaron Frey on Monday, June 14, 2021, to discuss our concerns with these awful emails. After the meeting we never heard from any of them about this matter. Civil Rights AAG Leanne Robbin remains in her position as Chief of Civil Rights, and although we asked neither Sen. Hickman nor Rep. Millett have ever spoke with my family about what was discussed, even though it was directly involved my family. The structure that will implement LD-1999 will need to be replaced or the law will be meaningless.

Even asking for these emails was met with derision by the Civil Rights AAG Leann Robbin, and the below emails was so insensitive that the OAG attempted to delete portions of it so it would be unreadable. Of note, beyond the extremely trauma my children and wife experienced, we had to discard or sell everything we owned and left a home we built just three years prior during a pandemic because we no longer felt safe. I am not retired, and her bias towards the school demonstrates why she never even attempted to investigate.
