Thank you, Committee.

I am survivor of violent crime and exploitation, Kerrie McAnulty.

Where does the line between criminal civil liberty manipulation end and victim/survivor rights begin?

Attorney General, along with York County District Attorney, Kathryn Slattery, jointly severally jeopardize the lives and livelihoods of several victims/survivors. Religiously catering to and enabling ongoing crime by convicted REPEAT violent offender, Keith David O'Leary is no longer pardonable.

I. Will. Not. Be. Quiet.

Why is the Attorney General's signature on plea down and deal after plea down and deal after Kathryn Slattery's on the same offender, same charges, same county. Criminal Keith O'Leary cannot rehabilitate, he is a textbook sociopath without the ability to hold remorse. He receives happy chemicals and gratification from harm and blood.

Where are MY rights. I was already trafficked and treated like garbage, why is this criminal still in society stacking body counts on authorities watch? Probation does not work for sociopaths. How many strikes can one actually have on the same charge within the same county within a short range of time?

I have a thirty year protection order out of York County, and I am supposed to be residing under a protected address under Secretary of States Office.

Due to ongoing and insidious manipulation by my offender, and negligence by the State of Maine, my offender has caught up to me again. I have worked excruciatingly hard to stay safe and sound. It is unpardonable my healing and life has been disrupted in 2024, when I fled abuse in 2015.

REPEAT convicted violent offender, Keith David O'Leary (4.7.65) is a relentless stalker, serial perpetrator of the law, and a massive public safety issue given how he offends.

I was trafficked, abused, attempted murder on my life at UpTown O'Leary's Tap located at 41 Old Orchard Street, Old Orchard Beach, Maine. Year after year this illegal and illicit business was relicensed by town and state, as well as LLC. at Secretary of State. How can this be? I use ACP. Secretary of State is same office protecting an exploited survivor, yet allowing an illegal business to continue to claim more body counts and livelihoods?

Drugs and firearms are involved with this offender. Massive amounts of cocaine, marijuana and beyond are tied to his criminal activity. Keith O'Leary just acquired 6.5 acres of land in the woods he cannot legally develop. 419 Middle Road, Steep Falls (Standish), Lot #17. He put in a building permit for a temporary shed with utilities to Standish Town Hall. What are his plans if he funneled drugs through Soho's Tavern and UpTown O'Leary's Tap in Old Orchard Beach while being a teacher, coach, and dormitory supervisor at Thornton Academy, Saco. Criminal is still connected to illegal liquor licensing and property of 41 Old Orchard Street, Old Orchard Beach.

How is Attorney General still signing off on plea downs and deals regarding my offender when he is a convicted REPEAT violent offender. Premeditated actions, no hope of rehabilitation. Danger to society. Manipulative sociopath/raging psychopath.

Three separate females, three separate assaults on record out of same location of 41 Old Orchard Street, Old Orchard Beach, Maine. All tied to a town and state licensed business.

York County DA's Office go-to excuse is my offender is highly manipulative, and they urge survivors to forge change in Augusta. Lack of accountability is

unacceptable and unpardonable.

I am that survivor warrior to forge change. I am part of new law LD692. More laws to come including animal cruelty as my rescue canine hero, Etta Jameson was harmed by offender, Keith David O'Leary as well. She deserves justice. She is on my thirty year protection order as well.

We are in fatal danger. York County DA's Office said they had no funds to keep me safe even though they are a cause of my unsafety. I testified against my offender November 8, 2023, and no authority outlet had anywhere for me to go.

I do not want to die, I want to live. I want to help and advocate for others. Why is the State of Maine handing me back over to my predator, offender, abuser, rapist, trafficker, and to a monster that attempted murder on my life.

This is an offender that knocked me unconscious on several occasions, held me hostage at gunpoint, got me falsely arrested twice to deflect blame. An offender that has made serious threats to disfigure and dismember me. He already chomped down on my nose like a rabid animal threatening to bite it off. Now he has bought 6.5 acres of vacant land he cannot legally develop within very close proximity to my protected address of healing. He did this all under the supervision and negligence of the State Of Maine while on probation. Probation is claiming it is my responsibility to move. They claim no accountability. I have been moving around since 2017 to get away from my offender/stalker. THE YEAR IS 2024.

This is unacceptable and unpardonable.

I Will Not Be Quiet.
