Testimony of Survivor, Kerrie McAnulty

Survivor of convicted REPEAT violent offender, Keith David O'Leary (4.7.65).

\*NO\* violent criminals do not deserve confidentiality, nor freedom. I have no freedom as a survivor, and my protective status has been compromised time and time over.

Where does the line between criminal civil liberty end, and victim/survivor rights begin?

Can you imagine, a survivor in grave danger, with a thirty year protection order, living under ACP, on disability due to crime, forced to flee protected address, and NO HELP! Same survivor testifying on bills for everybody. Same survivor bringing light in York County, and beyond. Same survivor being thanked by students at Thornton Academy because my predator-offender was a teacher, coach, and dormitory supervisor to minors there as well.

Victims and survivors are already stranded. We are already in survival. The body is not made to be in constant survival, it is designed to thrive. I am divinely blessed, protected, and guided to have survived thus far. I may be a walking angel on earth as I should not look, think, talk, and walk the way I do given the evil hell unleashed on my body, but inside I feel ancient. My body is breaking down from the injuries and prolonged abuse. I have PTSD, Post-Concussive Syndrome, Migraines, Fibromyalgia, Arthritis, and the list goes on. Finally getting my nose fixed that my offender broke. He did not punch me directly in the face as he is a coward. He kicked and elbowed me in the face, then chomped down on my nose like a rapid animal threatening to bite it off. He considered me property, and an asset to exploit. When I did not obey his command he punished me into submission.

Abuse thrives in enablement. There is already far too many chances for offenders to manipulate the scene, and the system. Financial abuse is a large tool in a predator/preparator's toolbox. Forming dependency ensures evil remains in silence. I was trafficked by my offender at UpTown O'Leary's Tap in Old Orchard Beach, Maine. My offender still has my social security number as he took my security security card, original birth certificate, license, and whatever other information and property he could grasp with his fangs.

Year after year after my abuse, trafficking, assaults, attempted murder at 41 Old Orchard Street, Old Orchard Beach, Maine, this illegal business was continuously licensed by town and state. The LLC., continuously renewed by Secretary of States Office when I the survivor of this crime am also under the ACP of Secretary of State. This is an example of how manipulation by criminal, and lack of communication by authorities/professionals is incredibly dangerous and harmful. Public safety issue.

You see, you think you are free once you get away. That is where the true horror begins. Little resources, little support, big problems, a lot of pain. It is especially excruciatingly when your offender is a sociopath/psychopath, relentless stalker, serial predator, and REPEAT convicted violent offender out of York County, Maine alone since 2016.

I have had to move around. Flee violence as recent as present. I first fled abuse in 2015. The year is 2024. Why is my offender while under the supervision of the state parked outside my protected address, and negligently granted a switch by probation to be in my neighborhood? Probation confirmed they never vetted out physical address of criminal. This is the second time my offender has moved within extremely close proximity to me since fleeing violence, since being on probation, and since obtaining a protection order.

Probation addresses my offender as a client to me, which is completely offensive, and

high bar inappropriate. Probation in a safety planning meeting told me that the criminal has civil liberty. My sociopathic offender has now manipulated several probation officers this round of probation, and now on another new probation officer. Second term of probation for domestic violence since 2016, and where he already manipulated multiple probation officers as well.

Department of Corrections and Probation has compromised my safety and well-being time and time again not supervising criminal AT ALL. Liability and negligence is now directly connected to: Department of Corrections/Probation Region 1- Kim Carson, Denis Clark, Jared McGuire, Bradley MacDonald, Catherine Fisher, Troy Thornton, and now Lawrence Bruce DeCesare.

**CON BEHAVIOR CONTINUED... WHY IS MY OFFENDER ALLOWED SO MANY SWITCHES? NEGLIGENCE!!!**

Probation confirmed they never vetted out offender's physical address he was reporting (\*vacant land in the woods, \*no dwelling), and that they have never done a weapon check. BOTH are required by law.

**I. WILL. NOT. BE. QUIET.**

**NO!** Civil liberty to be a stalker, to violate my thirty year protection order with a dependent on it, to compromise my protected address, to follow me in my sealed plates and registration vehicle, to send me mail, to vandalize property, to threaten me to keep my mouth shut and to sue me for false slander of speaking my truth, my trauma. **NO!**

I choose to continue to save myself, heal myself, and help save lives.

The criminal in fact does not have a right to do any of these things he has been doing over and over, again. **ILLEGAL.** This is a massive liability on Maine Department of Corrections and Probation, York County District Attorney's Office, Maine Attorney General, Secretary of State, Old Orchard Beach Police Department, Old Orchard Beach Town Hall, York County Sheriff's Department, Cumberland County Sheriff's Department, Maine State Police, and the State of Maine system as a whole.

This offender has already threatened for me to be found floating, and I live in a lakes region. This offender has already threatened to dismember me. Probation cleared him recently to buy 6.5 acres of land he cannot legally develop, within my community of healing. Again, I fled abuse in 2015. I have moved all over, even states. I am now in the middle of the woods, trying to heal, advocate for ALL, forge change, and curate a beautiful life on the other side of trauma, and my offender/trafficker/stalker is trying to be right by my side again as an unwelcomed guest and fatal attraction neighbor. The system holding his hand, again.

His hands that were around my neck, all over my bloody body, and on the firearm I was held hostage with... His hands that abused my beloved rescue support canine, the hands that ripped chunks of hair straight from my scalp as he manically laughed with pleasure. Hands that knocked me unconscious where he then spit directly in my face, and was caught doing so. Hands that tried to videotape me after he assaulted me, me laying there with torn clothes, bloody, terrified, begging for him to stop, to leave me alone.

The premeditatedly violent and sadistic hands that then call the police to save himself time after time, every single time he assaults a female. This is a pattern that cannot and will not continue. Authority got it wrong way too many deadly times in the past. No more criminal manipulating the scene for scheme, and enablement by authority. No more false arrests on victims. Only allowance is heavy accountability on Keith O'Leary. The pattern is far evident. No more pardons, or I am sorry. Accountability is the only option at this point. Negligence and liability is far too public, and far too high.

Victim and survivors qualify of life far matters over any criminal civil liberty manipulating BS card. My offender took out a permit to build a temporary shed with utilities, on 6.5 acres, in very close proximity to where I reside. No authority looked

into this until I flagged it, and nobody wants to take accountability for this injustice. Accountability is unavoidable at this point.

My offender impersonated another man at town hall, and when you look up this man on the internet, that man is a producer of murder mysteries. My offender said if he did not finish me off for disobeying, that someone else would for him. Why is he now in my community again, with affiliates of his also tied to a property on my exact road??? The system has failed, and this negligence has to be rectified immediately, if not sooner. I will not be quiet about any of this.

You know how I found out he caught up to me? He was in my rearview mirror. Like a horror film. Fled abuse in 2015 in Old Orchard Beach. Now an hour away from where my offender should be under the supervision of the state, he is tailgating me and my rescue canine that is on my thirty year protection order. Terrifying, terrorizing, traumatized.

We will no longer be refugees of domestic terrorism by a serial domestic terrorist. We need services. Many victims and survivors need services. Without services those with authority to do the right thing are just handing us over to be murdered. We have already fought for our lives. Victims and survivors qualify of life is already compromised from abuse, and we certainly do not need salt in our wounds.

Emergency housing services have not been available to us as of late. In a time when my canine and I need it most. This must change for everybody and every being in need.

I have had to stay and live in my car when there is nowhere else to go, and that is devastatingly often.

November 8th, 2023 in Biddeford I testified against my offender as a witness to him violating probation. He continually applies for early release, and this is DANGEROUS. It was extremely difficult to be in the same room as my rapist, and within such close proximity. Why did State of Maine grave errors put me in this position in 2023 pushing 2024, when I fled abuse in 2015? It was my only option to protect myself, I had to honor myself. My offender should far already be in prison.

Why does the new courthouse have the defendant sitting so close to the witness stand, when offenders are already intimidating the victim into submission and silence? Major design flaw and miss, or corruptive intent. I persisted, and per usual pushed through the ongoing abuse.

Judge ruled my offender did not comply with probation after I testified on behalf of my offender violating my thirty year protection order at a protected address.

Injustices of broken and flawed system, REPEAT convicted violent offender to remain in the community, and I the survivor with legal protection advised by York County DA's Office not to return home! Eight years into the future after fleeing violence I am told not to go home!

UNACCEPTABLE. They also had nowhere for me to go, and said they had no funds. UNACCEPTABLE.

This is a convicted REPEAT offender out of York County alone, and many other victims were hurt and stranded by the system that is supposed to protect us. No more plea downs and deals for REPEAT offenders.

Coercive control is deadly, fatal, and needs to be illegal. America needs to get up with the times of Ireland. No one, no soul should control another. I am my own govern now. I will not be quiet about my abuse, and the injustices bestowed upon me, my loved ones, and fellow survivor sisters.

Three violent assault charges on three separate much younger females in same county (York), same crime scene location, yet offender Keith O'Leary is free, and hanging outside my protected address? NO.

I. Will. Not. Be. Quiet.
