At the moment of removal at about 1:30 a.m., all the nursing staff on duty formed an honor guard and escorted my father's body, me, and my brother out of the home for the last time. They showed us all as much caring and respect after my father's death as they had during his life.

At the time of my father's stay at the Maine Veterans Home there, I lived in Portland, also very convenient to Scarborough.
