Good afternoon Senator Rotundo and Representative Sachs. My name is Kandyce Powell, Executive Director of the Maine Hospice Council. Board members and staff of the Maine Hospice Council have been very grateful for a general fund appropriation from State Government since 1989.

When I pass the baton to the next generation, I do so knowing...

- a. We have brought credit to Maine through our innovative programming.
- b. Our programs and initiatives have been valued by colleagues in many other states and countries.
- c. Our work has addressed identified needs of underserved and disenfranchised populations through collaboration rather than competition.
- d. Our programs have helped transform the lives of many individuals.

It is also my wish that the organization may continue to be supported as an independent voice for Maine residents for years to come.

The Council has never received reimbursement from Medicare, Maine Care or other commercial payers because we do not do direct service work. The direct-service work is handled by capable colleagues in licensed Medicare Certified Hospice Programs. Augmented by the invaluable support from licensed independent hospice volunteers.

The Maine Hospice Council's long-term vision has been to promote universal access to quality end-of-life care through innovation, creativity, education, advocacy and collaboration. Sadly, the original general fund allocation in 1989 for the Council's operations has been decreased incrementally over the years, even though our programs and initiatives have increased exponentially. Today, MHC receives \$44,000 annually to maintain an office and employ one full-time Executive Director and one part-time Executive Assistant and a sub-contracted bookkeeper. We do receive an additional \$22,000; however, this is a pass-through to the independent hospice programs.

We have always been extremely frugal, grateful for every dollar we are given. My plea today is for an increase in the general fund allotment for the Maine Hospice Council in order to sustain its operations. In 1989, MHC received \$44,000. This would have a value of \$127,000 today. If the Appropriations Committee would consider increasing our present allotment by \$84,000, this would be extremely helpful. It would allow the Maine Hospice Council to maintain an office; to provide salaries commensurate with responsibilities; and to hire a part time grant writer in order to sustain our present work plan and continue addressing identified needs in our communities.

This would have a value of \$127,000 today. If the Appropriations Committee would consider increasing our present allotment by \$84,000, this would be extremely helpful. It would allow the Maine Hospice Council to maintain an office; to provide salaries commensurate with responsibilities; and to hire a part time grant writer in order to sustain our present work plan and continue addressing identified needs in our communities.
