I travel down to spend a week with here on the anniversary of

her son's death. It has been nine years.

October 25,2023 lockdown.

Lewiston, Maine shooting. My family and I had to be in

My grandchildren had to miss days of school and suffer

more emotional

upheaval due to a hideous act of violence.

The citizens of Maine young and old alike do not need any type of weapon that was designed for the battlefield or equipment that can make a gun machine gun ready. No one has a need to have a gun that shoots 45 rounds or more! of ammunition in under a minute. We only need to look at the history of mass killings in our country to know this. How awful it was for the mass shooting at an elementary school in Newton Connecticut did not stop this madness. How devastating that we let it continue due to politics.

There is no other reason that this in fact does continue. This is not about one's right to own a gun. Have your gun (s) but, once again you do not need an instrument or accessories that make it a piece of military equipment. My sons who are veterans tell me that weapons in the military are treated with respect of the power they have.
