To the members of the Judiciary Committee,

Thank you for taking the time to read my testimony, I'll be brief.

On October 25th 2023 a tragedy occurred in Lewiston, a tragedy that should not have occurred with the current Yellow Flag law on the books, but it did. From what I understand there were several opportunities from the State mental health services, the Sagadahoc County Sheriff's Dept. and our U.S. military to prevent this event. However, none of them seem to follow through. What is the purpose of passing common sense laws when they are not enforced? Instead, there is now discussion about restricting my Constitutional rights, because somehow I and thousands of other Mainers are to blame for the inaction of our State mental health services and law enforcement.

These tragic events took place in a "Gun Free Zone", I guess the gunman did not see the sign on his way in, maybe the signs need to be larger.... However, many law abiding citizens who would normally have carried a firearm, did not. They adhered to the "sign", and followed the "law". How foolish is this? When will legislators learn that criminals DO NOT adhere to your laws and regulations? Instead we see around our country, schools and businesses that are attacked in a so called "Gun Free Zone". You are setting up "soft targets", as they are called. Sadly, like shooting fish in a barrel. Is this truly what you want for our country and state? I don't think it is. Had there been one, two or more citizens in that first facility with firearms this event may have turned out differently.

Our Democrat Governor is currently allowing thousands of illegal immigrants into our once safe state. That right there should scare you. Statistically, Maine is the safest in the nation, or was. The Governor's goal is 75,000 illegal immigrants in the next 5 years, we haven't had that many people relocate to our state in the last 24 years (The Maine Wire, Maine Governor Wants to Resettle 75,000 Foreign-Born Migrants in Maine by 2029, 8/23/23), This is crazy beyond belief! Aside from the financial burden she is placing on the state taxpayers, she is pushing aside true Maine citizens who are already in a tough situation and giving their benefits to illegal immigrants. As citizens, we certainly don't want to live that way, but we have the constitutional right to do so when necessary, with any firearm of our choosing to protect our families. Don't hobble us. You would not want someone taking away your right to protect your family by whatever means you felt necessary. It's not the firearm, it's the person holding it and for what reason. If a crazed person drove a car through the balloon festival and killed as many, would you ask that cars be limited in design or availability? Maybe ban them all together?? Of course not.

There are many outside paid influencers that like to get on busses in other states and come here and scream. You, as <u>elected Maine representatives</u>, have no business listening to, or taking <u>advice from these outside organizations</u>. They have an agenda. Don't be that representative that bends to outside influence.

In closing I would like to remind you of our Second Amendment:

"A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed."

Note, it says "<u>shall not be infringed</u>", that's all you need to know in making this, or any future gun legislation. I urge you to please vote against any further gun restrictions against law abiding citizens.
