Testimony of Jeremy Cluchey of Bowdoinham, Maine

In SUPPORT of LD 29

Resolve, to Require the Department of Transportation to Implement the Recommendations of the Lower Road Rail Use Advisory Council

March 4, 2025

Senator Nangle, Representative Crafts, and Members of the Joint Standing Committee on Transportation:

My name is Jeremy Cluchey and I live in Bowdoinham. I am testifying in support of LD 29 as Chair of the Merrymeeting Trail Board of Supervisors. This body was created a decade ago through an interlocal agreement by the municipalities of Topsham, Bowdoinham, Richmond, and Gardiner to work with the state in pursuit of repurposing the long-dormant Lower Road corridor as a trail.

Over the past several years, we have worked to support MaineDOT's rigorous, transparent Rail Use Advisory Council process. I served on the council, and in August 2023, after reviewing substantial data and hearing significant public comment, we voted overwhelmingly to recommend Maine repurpose the corridor as a trail on an interim basis. This is the process laid out by the Legislature, and this is the recommendation before you today.

As Chair of the Merrymeeting Trail Board of Supervisors, I am here to state our commitment to continue working constructively with MaineDOT to move this project forward in close coordination with the communities along the corridor. These municipalities have repeatedly demonstrated their support for the Merrymeeting Trail over the years, and each has also endorsed LD29. I include copies of their letters with my testimony.

Also included are the names and towns of over 450 residents, businesses, and organizations that have signed our letter in support of LD 29. Many of these folks also participated in a series of Community Conversations we held this fall, where hundreds of local residents gathered to discuss how they would use the trail. These communities are deeply excited about the prospect of this project.

In order to be respectful of the committee's time, we encouraged many local supporters of LD 29 to submit written testimony, which they have done in droves. I want to highlight a few of the diverse examples I read on the committee's website:

Mark from Farmingdale: "As a lifelong resident of the area, and as both a Banker and Real Estate professional, I've used these trails to promote growth in the community. Trails such as these are among our greatest assets."

Katherine from Gardiner: "I would frequently use the trail to travel between Gardiner and Richmond as there are many historical sites. As a history teacher, there is so much history along the Kennebec River in this stretch that could be used as an accessible field trip for students."

Sarah from Bowdoinham: "Our property abuts the proposed trail and we are fully in support of LD 29! We plan to volunteer to support maintenance and care of the trail and look forward to sharing this resource with our neighbors."

You'll hear from a number of other folks today who will touch on the key facts and figures that have made it abundantly clear that the choice we face on this corridor is not whether to use it for trail or train, but for trail or nothing, as has been the case for the better part of four decades. Taxpayers deserve a better return on their public infrastructure.

Finally, I understand that late last week, a letter of interest from a rail operator was submitted to MaineDOT for the Lower Road. Given that no such interest has been voiced in many years, including during the very public RUAC process, the arrival of this letter days before this hearing might fairly be considered curious. Still, it's important that the Department takes the time to review the proposal and see how it accounts for the hundreds of millions of dollars that would be necessary for passenger service.

After decades of studies and data all saying the same thing, our communities are ready to proceed with the Merrymeeting Trail. LD 29 doesn't get us there – there will still be much work to do – but it is an essential next step. On behalf of our communities, we hope you all will support us in making it, together.

On behalf of the Gardiner City Council, I write to express the council's full support of LD 29: "A Resolve to Require the Department of Transportation to Implement the Recommendations of the Lower Road Rail Use Advisory Council." For many years, it has been our hope to see the unused rail corridor which runs 33.5 miles between Gardiner and Brunswick converted to a pedestrian and bicycle trail, known as the Merrymeeting Trail, connecting with the existing and heavily used Kennebec River Rail Trail, which runs north along the Kennebec River to Augusta.

One of our council members participated in the Lower Road Rail Use Advisory Council and provided us with their report. Considering this information, we endorsed the Rail Use Council's recommendation to create an interim trail along the Lower Road. The most economical and environmentally sound way to do this is by removing existing rails and track bed and building a stone dust or paved pedestrian and bicycle trail within this corridor.

During the Rail Use Council process, many residents and business owners in Gardiner and in communities along the corridor turned out to voice their enthusiastic support for the Merrymeeting Trail, their recognition that rail service is not currently viable, and their excitement for the many ways it would benefit the community.

This corridor has amazing views and access to the Kennebec, Androscoggin and Cathance rivers, and would connect our communities to other state and national trails. Such a trail would have a measurable positive economic impact for our city, region and state.

Now is the time to capitalize on growing public support for green and healthy transportation infrastructure and to reimagine this historic corridor for a new future. We urge you to support LD 29.

LD 29 - Lower Road Rail Use Advisory Council

Dear Members of the Legislature,

On behalf of the Bowdoinham Select Board, I am writing to express the Board's full support of LD 29 and the implementation of the recommendations of the Lower Road Rail Use Advisory Council's majority report.

The Merrymeeting Trail would provide an incredible opportunity for alternative forms of transportation for this region and our state, as the trail would connect:

- Androscoggin River Pedestrian Bike Path in Topsham that links Brunswick to Topsham;
- the village area in Bowdoinham;
- the village area in Richmond;
- the village area in Gardiner; and
- Kennebec River Rail Trail that links Gardiner, Farmingdale, Hallowell, and Augusta.

By connecting the Androscoggin River Bike Path (2.5 miles long) in Topsham and the Kennebec River Rail Trail in Gardiner (6.5 miles long), the Merrymeeting Trail would transform these two separate trails into a 34-mile-long intrastate trail connecting our State Capital and Maine's largest Town. Additionally, the Merrymeeting Trail could serve as an alternate route on the East Coast Greenway, a 3,000-mile national trail linking Calais, Maine with Key West, Florida.

Merrymeeting Trail would contribute to the quality of living in Midcoast Maine. It would provide a safe, inviting facility to support healthy communities. As well as draw people to our region, creating economic development opportunities and support downtown revitalization by bringing trail users into our village centers.

Dear Members of the Transportation Committee of the Maine State Legislature,

The Town of Topsham has participated in discussions and planning related to the proposed Merrymeeting Trail since 2008 and has had representatives on the Merrymeeting Trail Board of Supervisors since its establishment in 2015. We believe a trail along this corridor, if done thoughtfully and in close collaboration with local municipalities, could benefit our community.

Topsham also participated in the Rail Corridor Use Advisory Council (RUAC) process for the Lower Road in 2022-2023. The majority report from that process recommended that the Maine Transportation Commissioner "work with the Merrymeeting Trail Board of Supervisors and individual towns to identify potential trail segments where limited motorized use may be permitted, such as where there is space for dual trails" or multi-use of one trail. We do not agree with the Majority Report's assertion that the trail should be for non-motorized uses only.

Your committee is currently considering LD 29, which would "Require the Department of Transportation to Implement the Recommendations of the Lower Road Rail Use Advisory Council." The Town of Topsham is supportive of this effort; however, we want to make clear that it is <u>very</u> important to our community that the opportunity for motorized and other types of trail use be included in any trail planning with Maine DOT and that all trail users are able to utilize the segment of the Lower Road located in Topsham. If Maine is to abandon its critical public transportation infrastructure, then as many taxpayers as possible should benefit from the new use – not just a small segment of the population. We want to be certain that the RUAC's recommendation regarding motorized access is honored in this process.
