Re: LD 742, An Act to Permit Telehealth Services Across State Lines Following Referral from a Primary Care Provider Based in the State

Dear Senator Bailey, Representative Mathieson, and Members of the Committee:

I am writing on behalf of the Department of Professional and Financial Regulation's Office of Professional and Occupational Regulation ("OPOR"), an umbrella agency that supports 38 licensing boards and programs. OPOR's sole purpose is to protect the health and welfare of Maine citizens, and it does so by licensing professionals who meet the minimum qualifications in statute, by investigating allegations of unprofessional conduct or incompetent practice, and by imposing sanctions when deemed appropriate. To that end, OPOR submits this letter in opposition to LD 742 as it does not provide state boards the jurisdiction necessary to protect the public.

More specifically, LD 742 seeks to amend OPOR health practitioner licensing statutes¹ authorizing health care providers in another state to provide telehealth services into Maine without a Maine license. A Maine license is what gives a Maine licensing board the jurisdictional authority to investigate and address complaints of unprofessional conduct or incompetent practice. Without a Maine license, there is no jurisdictional authority over an out-of-state licensee providing care in Maine. Additionally, the out-of-state provider's home state will not have jurisdiction over care provided by their licensee to patients in Maine.
