Maine cannot seem to keep with illicit massage businesses at bay. Businesses that are staffed by several licensed MT's who all have the same name. A person who was arrested for prostitution in Rockland recently, at a business associated with sex trafficking, is licensed and remains licensed. The state needs to address this before they start informing me, I have to take another test and prove my worth. I have already done that.

The compact will not allow grandfathering. Why is that? I think forcing us rather than grandfathering us allows for their revenue stream to compensate themselves.
