

## TESTIMONY OF ALICIA REA, ESQ. LD 731 – Ought to Pass

## An Act to Prohibit Municipalities from Barring the Creation of Homeless Shelters

My name is Alicia Rea and I am a policy fellow at the ACLU of Maine, a statewide organization committed to advancing and preserving civil liberties guaranteed by the Maine and U.S. Constitutions. On behalf of our members, I urge you to support LD 731.

If enacted, this bill would prohibit municipalities from adopting moratoria on the establishment of shelters for persons experiencing homelessness.

According to Maine Housing, homelessness in Maine has more than doubled in the past decade, from 1,200 people in 2014 to 2,695 people in 2024. In addition to more clients who need services, the funding model for these shelters means operating with an annual deficit of approximately \$4 million. Experts agree that more is needed from all government authorities. Maine lacks enough shelters, and a shelter shortage increases burdens for jails and prisons, law enforcement agencies, and hospitals.

In addition, a lack of shelters could mean unconstitutional deprivations of the civil rights and civil liberties of unhoused people forced to live outside, such as forcible displacement in violation of due process, disability discrimination, and infringement on First Amendment rights.
