Submitted to the State of Maine Transportation Committee's March 27th hearing on LD 989 - An Act to Recognize Amateur Radio License Holders by Waiving Fees for License Plates Displaying Call Signs

Dear Committee Members,

Several years ago when applying for my FCC call sign on my license plate I was surprised that Maine didn't have this ability, that in fact it used to, and to top it off that Maine is the only state without a program for amateur radio recognition on motor vehicle plates.

I have been collaborating with Sen. Tipping on this effort for over two years and have met with the Secretary of State, leadership staff at the Bureau of Motor Vehicles and have discussed this initiative with hundreds of amateur radio operators - of which there are 4,382 licensed in the state of Maine. Amateur radio is often given the tag line "When All Else Fails" and many of these operators directly support their community in a wide array of service.

I am submitting testimony of data collected from submissions to an online form for Maine amateur radio operators who support this initiative, that includes how they support their community as well as their specific comments.

LD989 is designed to minimize fiscal costs but I would hope that in the future the committee would support taking it a step further while still minimizing costs. I would propose a plate to make the general public aware that what may otherwise look like random characters, is actually an amateur radio operator. This would raise awareness similarly to how we highlight our first responders, noting that they are not charged annually for a vanity or specialty plate. I am not suggesting a custom specialty plate but rather a die to stamp/emboss the bottom of the plate used by several services such as for coach vehicles. Instead of imprinting "COACH" on the Coach plate, "Amateur Radio" could be stamped at the same time as the callsign. This would not require printing additional specialty plates and minimize cost while demonstrating that the operator could assist when there are no other communications. Many other states recognize this value and either include an embossed lighting bolt, "Amateur Radio," or a specialty plate.

The Maine House and Senate has repeatedly issued joint resolutions "on behalf of the people [they] represent, [for the] opportunity to recognize and acknowledge the accomplishments and public service provided by amateur radio operators." I do hope the Transportation Committee will also recognize amateur radio's public service and will support LD 989 as introduced.

When normal commercial communication such as cell phones and land based lines fail. The Amateur Radio community responds by providing, free of charge, world wide emergency communications in the event of disasters. This is usually the only means of communication for the areas effected by disasters such as tsunamis, earthquakes, severe hurricane force storms, fires and cyclones. Amateur radio gives the affected areas a means to ask for aid and assistance from areas that are unaffected by the disaster. This is why most of the world's countries allow Amateur Radio to exist and protect the part of the radio spectrum that amateurs need to provide this service. Amateurs enjoy the privilege of being able to talk to friends around the world; I guess that is why they are also known as Hams.

But at the same time, they are learning how to communicate. The Amateur Radio Frequency bands may not be used for broadcasting or any other commercial uses. Amateur radio encourages the licensed Hams to excel and improve their skills by holding contests and awards certificates to hams that, during the few days of a contest, can contact the most other hams or the most other countries as well as other categories.
