When the idea of town moratoriums was brought up in Harpswell, the Selectboard authorized and held two public Workshops leading to the decision to form an Aquaculture Working Group to address the issue directly.

As a former legislator, two-term House chair of the Marine Resources Committee and a resident of Harpswell, I attended both Workshops and volunteered to be a member of the new Working Group. At each Workshop and in the Working Group, I stressed that aquaculture licensing and leasing are the purview of the State of Maine, not of municipalities and that we shouldn't waste time or resources on an ill-advised effort that only, in my opinion, increases conflict and ill will.
