Re: Testimony Opposing LD 607: A Threat to Educational Integrity and Local Community Control

Dear Senator Rafferty, Representative Murphy, and Honorable Members of the Committee,

I write in strong opposition to LD 607, which mandates that Superintendents approve agreements for students to attend schools outside their residency if the receiving school has capacity. This bill presents two major concerns.

Schools like those in Brunswick—known for high-performing educational environments—would be forced to absorb non-resident students with minimal additional funding. This is not just unfair; it is a potential recipe for educational deterioration.

#### **Consider the cascading effects:**

- Increased class sizes that dilute individual student attention
- Stretched resources that compromise educational quality
- Potential budgetary pressures that could lead to program cuts
- A disincentive for communities to invest deeply in their school systems

## **Impact on Sending and Receiving Districts**

The bill creates a lose-lose scenario for school districts:

- Receiving districts face resource strain and potential quality degradation
- Sending districts risk curriculum narrowing and program elimination due to declining enrollment

## **Preserving Maine's Educational Philosophy**

Maine has always prided itself on local control and personalized educational approaches. This bill represents a fundamental departure from those cherished principles. It transforms education from a carefully curated, community-driven experience to a transactional, one-size-fits-all model.
