Dear Members of the Committee,

My name is Roger Fuller, I live in Lewiston. Thank you for the work you all do to represent Mainers from across the state. And, thank you to Representative Cloutier and the co-sponsors of LD814 for bringing this important legislation forward

I am a board member of Seniors Plus, serving the residents of Androscoggin County. I am here today to testify in strong support of LD814 An Act to Provide Funding to Area Agencies on Aging for Community-Based Services and Programs to Support Older Adults. I will refer to this as the Older Mainers Act, sponsored by Representative Cloutier. The Older Mainers Act is crucial for several reasons

- Promotes Independence: By providing hands-on, wraparound case management services, the Older Mainers Act will help older Mainers stay in their homes longer, delaying the need for institutional care and allowing them to age in place, as more than 80% of older adults wish to do.
- Eliminates Waitlists for Meals on Wheels: A 5 year study from Brown University shows that Meals on Wheels reduced hospitalization rates by 31%, emergency room visits by 28%, and nursing home placements by 28%. This is a life-saving and money-saving service, yet currently over 600 older Mainers are on waiting lists for these services. The Older Mainers Act would allow for more than 335,000 additional meals to be provided across the state.
- Increases Financial Security: Through enhanced Medicare education, counseling, and application support, the Older Mainers Act will save Mainers money, allowing them to stay in their homes and reinvest in the economy.
- Supports Caregivers: Through programming, the Older Mainers Act would provide respite and essential resources to balance work, personal health, and their caregiving duties. Each year, more Mainers become caregivers for their parents, children, and grandchildren. AARP estimates that 61% of family caregivers also hold down a job, so this support is critical to keep them in the workforce.
- It is a critical investment: Investing in the Older Mainers Act now will save the state money now and for years to come. The preventative programming the Agencies on Aging provide is proven to delay and keep people out of long term care facilities, which cost significantly less than nursing home care. This alone is reason to support the bill.
- Builds Community and Reduces Social Isolation: Maine's Area Agencies on Aging e country, such services are essential to the health and wellbeing of older Mainers.

As a board member, I have seen firsthand the positive impact that these services have on our community. I know just how important this agency is for many community members who benefit from the services offered by Seniors Plus.

Supporting the Older Mainers Act is an investment in the health and resiliency of our communities. It ensures that every older Mainer has access to essential benefits, community, and services, can stay in their home if they choose, and that caregivers receive the support they need.

I urge you to support the Older Mainers Act and help us continue to provide these vital services to our older residents. Doing so will improve the lives of older adults in Maine for generations to come.
