Re: Testimony In Support of LD 1293- An Act to Prohibit Coyote-killing Contests in Maine

Dear Senator Baldacci, Representative Roberts, and Members of the Committee on Inland Fisheries and Wildlife:

My name is Gina Garey and I am from Portland where I serve as State Director for the Center for a Humane Economy and Animal Wellness Action. I am here to submit testimony in support of LD 1293, An Act to Prohibit Coyote-killing Contests in Maine.

Today, no doubt, you will be hearing from wildlife officials, advocates, biologists and local advocacy organizations about the egregious practice of incentivized killing games taking place in Maine, targeting the coyote, our state's only remaining predator. Rewarding the indiscriminate killing of as many animals as possible violates conservation ethics and its humane values.

You will learn that ten states have already enacted prohibitions against this blood sport, with five states, including Maine, considering joining the movement to put an end to this unethical aberration of coyote group massacre events for prizes. The US Congress has introduced its own legislation to put an end to this unsportsmanlike activity across the country.

You will hear from experts across the wildlife research community providing long standing evidence that excessively targeting coyote populations does little to protect deer herds, while their presence is a contributing factor towards the prevention of Chronic Wasting Disease in deer populations. CWD is spreading across western and other states rapidly, with strong evidence that the best management tool we have is a robust, self-sustaining predator population to keep CWD in check and maintain healthy herds for the hunting community.

You will hear that mass removal of a wildlife species from the environment impairs the ecological benefits these animals provide to both urban and rural communities. Predator and prey species are vital to a healthy ecosystem. With man's eradication of wolves, coyotes are essential to control rodent and small mammal populations, cull sick and injured animals and wildlife that harbor ticks / Lyme disease.
