A few weeks ago, I stood on the floor of the Illinois House to say what too many politicians are afraid to admit: Our constitutional rights are under coordinated attack and the Anti-Defamation League (ADL) is not just silent, they're celebrating it.

We cannot let the ADL and their far-right allies weaponize antisemitism to criminalize dissent, delegitimize Palestinian lives, and bulldoze the First Amendment.
