These small-scale improvements can have a significant impact.

program remains accountable and responsive to the needs of the families and businesses it serves.

By supporting the construction, retrofitting, and renovation of childcare facilities, LD 483 will help meet the increasing demand for childcare services. This is not just about caring for our children—it's about ensuring that Maine's economy can continue to grow and thrive as more parents can fully engage in the workforce.
