



Testimony before the Joint Standing Committee on Judiciary
March 26, 2025

I am Rev. Jane Field, Executive Director of the Maine Council of Churches, a nonprofit coalition of seven mainline Protestant member denominations that have more than 400 congregations in Maine with over 50,000 parishioners in their care.

The central value of love of neighbor grounds the work of the Council, and we take seriously the biblical imperative to **protect the vulnerable and hold those who harm them accountable**. It's because of these core values that the Council supports passage of LD 1120, 1299, 1104, and 1174 and opposes passage of LD 208, 1230, and 1062.

Maine's faith leaders and the congregations they serve know far too well the trauma and grief of losing loved ones to gun violence. We pray for and stand in solidarity with survivors and declare our support for those who still struggle in the face of trauma and grief. And we are clear: **it is time to reclaim our homes, streets, schools, and workplaces from the threat of gun violence**, and it is time to take back our power to create safe and peaceful communities—to **reclaim it from the narrow special interests** that seek to block even modest, common-sense measures to prevent gun violence and promote gun safety and responsible gun ownership.
