Testimony in Support of

An Act to Strengthen Coordination of Community Transportation – LD 1451
April 23, 2025

Good afternoon, Senator Nangle, Representative Crafts, and honorable members of the Committee on Transportation. My name is Adam Bloom-Paicopolos. I am a resident of Wells and am proud to serve as the Executive Director of the Alliance for Addiction and Mental Health Services, Maine (the Alliance). The Alliance is the statewide association representing Maine's community-based behavioral health agencies who provide much-needed mental health and substance use services to over 80,000 children, adults, and families annually. The Alliance advocates for the implementation of sound policies and evidence-based practices that serve to enhance the quality and effectiveness of our behavioral health care system.

On behalf of the Alliance, I am here today to speak in support of LD 1451, "An Act to Strengthen Coordination of Community Transportation."

Community behavioral health organizations in Maine are deeply committed to increasing access to care, and we know that transportation is critical factor for individuals and families to get the support they need. For the thousands of Mainers our members serve— many of which reside in rural areas— transportation insecurity is a significant barrier that often prevents them from accessing vital services. When individuals cannot attend therapy appointments, access medication management, or get to group programming due to lack of reliable transportation, their health outcomes suffer.

In 2023, Maine spent over \$200 million on community transportation. Yet, a recent survey found that 40% of Maine adults experience transportation insecurity. LD 1451 represents a smart, strategic step toward fixing that gap by maximizing coordination across state agencies and building on national best practices.

The Alliance strongly supports this legislation because it strengthens coordination, increases efficiency, and opens the door to additional federal funding to improve this important service. The proposal to create a state-level coordinating council and support regional Mobility Management Hubs will help connect people to the services they need in a more streamlined and equitable way. For community behavioral health providers, that means fewer missed appointments, greater continuity of care, and better outcomes for the individuals and families we serve.

Maine's behavioral health system is already in crisis, with long waitlists, workforce shortages, and inadequate reimbursement rates to maintain access to services. Transportation should not be an additional barrier for Mainers accessing lifesaving care. LD 1451 gives Maine the tools to move forward with a system that is more accessible, community-driven, and sustainable. I respectfully urge you to support

LD 1451 and help Maine take a meaningful step towards ensuring that no one is prevented from accessing care simply because they can't get there.
