LD 1605 An Act to Support Farmers and Food Banks Affected by Federal Cuts to Their Existing Contracts

Vernon Food Bank, and a member of the Board of Directors of the Maine Council of Churches where I serve on their Public Policy Committee. I am testifying in my capacity as a pastor and food bank volunteer, and on behalf of the Council **in support of LD 1605**.

The Mt. Vernon Food Bank feeds 85 families from the communities of Mt. Vernon, Fayette Vienna and Readfield. The **number of families needing food is growing**. The more than 400 local churches that belong to the Council's seven mainline Protestant member denominations are seeing the same growing need in their communities, too. It's disheartening to me, my congregation, my community, and to the Maine Council of Churches that there are so many Maine families that don't have enough money to purchase the food they need.

In the midst of this growing need, we are now seeing reductions in The Emergency Food Assistance Program (TEFAP), a federal program that provides emergency food for low-income people, as well as reductions in the amount of USDA surplus foods. We are also concerned with the negative impact on Maine farmers whose federal grants are being reduced or canceled and what it might do to food banks that rely on a supply of food from those farms.
