I submit this testimony in strong opposition to the following bills:

**LD 233, LD 868, LD 1002, LD 1134, LD 1704, LD 1337, LD 1432, and LD 380.**

These bills are not about protecting fairness or safety. They are about excluding and isolating young people who already face disproportionate bullying, mental health challenges, and barriers to participation. I am the mother of a 23-year-old transgender son. Though he did not participate in school sports, these bills would have deeply affected him—invalidating his identity, restricting his access to spaces where he should have felt safe, and sending a clear message that he did not belong.

As a minister and mother, I have seen firsthand how vital it is for trans youth to be affirmed and supported. I know from my faith and my experience that every child is a sacred gift. These bills move us in the opposite direction—toward fear, marginalization, and harm.
