

Testimony from the University of New England to the Committee on Taxation

LD 1795: An Act to Change the Calculation for Municipal Service Charges for Tax-exempt Organizations, and

LD 438: An Act to Allow Municipalities to Limit Nonprofit Property Tax Exemptions

Thank you for the opportunity to submit testimony in opposition to both bills. Even though there are differences in these bills, the outcomes are the same for Maine's independent colleges and universities. Levying additional taxes will negatively impact our business, make a college education less affordable, and decrease the critical services that we provide Maine communities throughout the year.

The University of New England (UNE) has two Maine campuses located in Biddeford and Portland and a third campus in Tangier, Morocco. UNE serves over 11,000 undergraduate and graduate students annually. Approximately 25% of undergraduate students are from Maine. UNE directly employs over 1,400 on its Portland and Biddeford campuses and provides (directly and indirectly) nearly \$150 million in total earnings across the region.

UNE strives to provide a high-quality educational experience for all of its students and it takes its responsibility as a Maine workforce development provider seriously. In 2023, UNE awarded \$12.6 million in scholarship to 720 Maine students. Over 95% of undergrads are employed or in graduate school within a year of graduation. UNE is the top provider of healthcare professionals to the State of Maine. UNE has received commendations for improving the financial well-being of its students as measured by their earnings post-graduation. As a result, UNE students have some of the lowest loan default rates in New England and well below the national average. The return on investment for our students is high.

There are numerous examples of UNE's contribution to the local communities but for this testimony, we will focus on the work of our students, staff, and faculty on supporting community health. UNE educates approximately 2,500 health professions students annually. An integral part of their education, and UNE's mission, is community service. The following are some examples of what this looks like:

- In 2023, UNE's health clinics received nearly 20,000 visits and provided health services at a reduced rate or at no cost.
- UNE dental students have annual rotations at public health care providers around Maine and UNE hygienists provide services at a number of schools and WIC sites.
