My name is Kit Wang. I'm a homeowner and resident in York. I am here today testifying in opposition to the bills before the committee today.

As a parent, former public school teacher and parish priest, I understand that these bills are bad for schools, bad for children, and protect no one, girls and women in particular. These bills leave all girls at risk of additional scrutiny and vulnerable to harassment. They leave ALL girls vulnerable to invasive and traumatizing "gender checks," and encourage spectators and others to bully and harass girls for not being "feminine enough."

A 2021 study in the journal, *Sports Medicine*, found no scientific evidence supporting bans of transwomen and girls in sport<sup>1</sup>, and a 2024 study in the *British Journal of Sports Medicine* found that transwomen may even have some physical disadvantages when competing against cisgender women<sup>2</sup>.

All this attention paid to a very small percentage of humanity is scapegoating and distraction. It is particularly distressing that these scapegoating efforts take up time, energy, and resources of the legislature, school officials, teachers, parents, and the children's schools are expected to serve when there are plenty of real, significant issues facing Maine's schools and schoolchildren.

Maine has had a well deserved reputation for freedom and respect for the civil and human rights of individuals, and a culture of support and care for those on the margins and at risk. It is time (again) for Maine to stand on these values and reject scapegoating and falsehood, and continue to support and protect the truly vulnerable.
