It probably won't surprise you to hear that the vast majority of challenges we face in Maine today have nothing to do with either restrooms or athletics. Despite this clear fact, the bills before you today rationalize their existence by hyperbolically framing these issues as if the current, lawful status-quo of Maine is perpetuating significant harm and substantial injustice to our local communities.

These hollow rationalizations stand in direct contrast to very real, overt hostility and threats our school has experienced as a result of complying with Maine state laws.
