I'm offering testimony today, regarding LD 1823 "An Act to Promote Transparency in the Criminal Justice System by Requiring the Posting of Criminal Case Decisions." This bill requires the Attorney General to post to the publicly accessible website of the Office of the Attorney General the final decision of a criminal case decided within the State within 60 days of the case's final disposition.

Simply put: accountability matters. However, the way it appears now, there is absolutely no accountability by many, if not all, of the district attorney's offices. All too often, cases are initiated by the police and fall into the abyss when the cases are in the hands of the district attorney offices and courts. I know from experience that there is no perfect case for prosecutors but the police in this State are doing their jobs. They are enforcing the laws - but the D/As are dismissing cases, giving plea bargains and deferred dispositions or just ignoring the cases all together citing 'prosecutorial discretion.'
