Many have been turned down for jobs, housing, or other opportunities that often trap them in a cycle of dependence and financial instability. Often, these men and women have completed job-training or career-oriented programs while incarcerated and are eager to apply their new skills to support themselves, dependent children, and aging parents and to contribute back to society as tax-paying citizens.

The stigma and specter of a served sentence should not continue to hinder individuals once they have demonstrated successful reentry and the ability to avoid reoffending. Sealing records for certain crimes will help clear the path to personal independence and successful reintegration.
