Dear Senator Baldacci, Representative Salisbury, and honorable members of the Committee on State and Local Governance, my name is Rebecca Abuza and I am a resident of Wiscasset. I work as a Maine Guide. As a Jewish person, I support LD 1383 for personal, statewide, and global reasons. My family emigrated from Russia (modern day Ukraine) in the 1880s, fleeing anti-Jewish riots and campaigns. The use of the Russian army against Jews at that time, mirrors the grotesque role of ICE on US streets today. Over a hundred years ago, my family struggled to obtain resources and documentation to flee persecution. They stole documentation and changed their name. If this 1880s family lore were unfolding in the present day, my family would be in a detention center. It is extremely disheartening that in 140 years we've made backwards progress in honoring the inherent worth and dignity of every person. ICE terrorizing communities is not the answer in the United States and Genocide is not the answer in Palestine!

It is vital that Maine divest from assets that tie the state to genocide and human rights violations. In order to uphold and fight for humanity world-wide, Maine must let its residents know that it is not funding the mechanisms that tear our community apart. Passing this bill is a signal to every Mainer that our state government is not complicit in the horrors of this moment that are being enacted and normalized by the federal government.
