My white neighbors and I are currently rallying to literally hide our asylum seeker neighbors. We are escorting their children to and from school, we are driving them to and from work, we are doing grocery shopping for them. They are afraid to leave their homes.

They are Maine residents who have lived here for years. They are here legally, they work multiple jobs, they pay taxes, they have no criminal records, and yet they are living in fear.
