Testimony of Senator Pinny Beebe-Center introducing LD 178, "An Act to Support Reentry and Reintegration into the Community"

Before the Joint Standing Committee on Criminal Justice and Public Safety

March 13, 2023

Good morning, Representative Salisbury and Distinguished Members of the Joint Standing Committee on Criminal Justice and Public Safety. I am Senator Pinny Beebe-Center, and I represent all of Knox County, except for Isle Au Haut and the town of Washington. I am here today to present LD 178, "An Act to Support Reentry and Reintegration into the Community."

This legislation seeks to create a supportive, restorative, and victim-sensitive parole system here in Maine. This will have multiple different facets that work together to create a strong parole program. This includes creating a seven-person parole board of professionals from diverse fields of expertise. This legislation will open an equitable avenue of responsible reentry that supports people returning to their communities from incarceration, providing that those who have been harmed are properly supported and that emphasis is put on community safety. This legislation will honor the judgement of courts and judges by keeping returning community members under Maine Department of Corrections (MDOC) supervision for the duration of their prison sentence. It will also partially rectify errors of the 1975 Criminal Code reform that abolished parole and expanded prison sentences.

Additionally, this legislation will provide universal eligibility of incarcerated community members to apply for parole only after serving one-third of the unsuspended portion of their sentence, and imbue the parole board with the discretion to deny that parole if the board determines that granting parole would be detrimental to society. LD 178 will support MDOC and community-based restorative justice organizations in their expanding implementation of Victim/Offender dialogue, supporting victims and survivors as they work to heal. Finally, this legislation creates a requirement of oversight and data collection for public transparency, which can help address racial disparities in sentencing and incarceration, a growing concern in Maine.
