RE: TESTIMONY IN SUPPORT OF LD673

Dear Committee Members:

I am writing in support of LD 673 An Act to Direct the Maine Criminal Justice Academy to Develop a Nonresidential Law Enforcement Training Program.

In York County, we are in the planning process of building an all hazards training center to support workforce development for all first responder disciplines. (IE: Fire, Police, EMS, Dispatch, Corrections, and others.) Construction is anticipated to begin in the fall of 2023. This facility is designed to provide nonresident law enforcement training programs. This facility will be in a position to augment MCJA programs by providing an alternate location and additional staffing to provide such training.

In-resident training in Vassalboro, is a hinderance to hiring quality individuals, including many veterans, who have family responsibilities. The requirements of in-resident training is often the single decision point for many not to choose a law enforcement career. The idea of a nonresident or "commuter" course may draw those individuals into law enforcement. Non-resident training can be more realistic than in-resident classes. In a commuter course, a student now has to juggle home life with work life.




TRAINING FACILITY RENDERING
