

Medically Managed Withdrawal Beds (AKA detox) in Maine Penobscot County (10 Adult Beds - Accessible):

New Horizons Detox Center: New Horizons is a Clinical Managed Detox Center, a program of Wellspring, Inc., located in Hampden, Maine. The program is dedicated to support and treat adults who are struggling with detoxing from opiates and/or alcohol. New Horizon Detox Center has 10 detox beds and requires the person call for an administration screening. In our experience the admission process is accessible, easy, and done with compassion.

Cumberland County (16 Adult Beds - Accessible):

Milestone Recovery: Milestone Recovery is a low-barrier detox center that serves adults who are seeking detoxification from all substances. The person must call the detox and undergo an admission screening. Admissions are only conducted between 7:30am-4pm daily. If you call them after those hours, they will screen you and if appropriate for services you will be required to call back at 8AM the next day to see if there is a bed. All beds are first come first serve and they do not keep a waitlist. In our experience the admission process is quick, accessible, and done with compassion.

Kennebec County (28 Adult Beds - Not Accessible):

Maine General 3 South Ward: Maine General has 28 beds on their 3 South ward that are used as both mental health stabilization and detoxification beds. People are required to present at the ER in Augusta and wait for an assessment there. The waits in the ER can extend multiple days and in our experience most people are turned away. The only time someone can access a bed is if they report to be suicidal or are detoxing from alcohol or benzo and refuse to leave till they are seen. In our experience the admission process is hit or miss and is traumatic for all involved. We rarely send people here.

Andro County (13 Adult & 6 Youth Beds - Not Accessible):

St. Mary's: St. Mary has 13 adult beds and 6 youth beds for mental health and detoxification. People are required to present at the ER in Lewiston and wait for an assessment there. The waits in the ER can extend multiple days and in our experience most people are turned away. The only time someone can access a bed is if they report to be suicidal or are detoxing from alcohol or benzo and refuse to leave till they are seen. In our experience the admission process is hit or miss and is traumatic for all involved. We rarely send people here.

Knox County (18 Adult Beds - Not Accessible):

Pen bay Hospital: Pen bay Hospital has 18 adult beds for mental health and detoxification. People are required to present at the ER in Rockport (or get a medical referral) and wait for an assessment there. The waits in the ER can extend multiple days and in our experience most people are turned away. The only time someone can access a bed is if they report to be suicidal or are detoxing from alcohol or benzo and refuse to leave till they are seen. In our experience the admission process is hit or miss and is traumatic for all involved. We rarely send people here.
