Testimony

My name is Dr. Christiane Northrup. I am a former board-certified OB/GYN surgeon. I served as an Assistant Clinical Professor of Ob/Gyn at Maine Medical Center for 25 years.

In December of 2020, I co-founded Maine Stands Up, a grassroots, state-wide organization whose mission is to stand for medical freedom and our God given rights.

I am here today to testify in favor of LD-51.

In 2020, this administration removed the God-given right of Mainers to determine what gets injected into their bodies, and those of their children.

Though medical exemptions were allowed, doctors who gave them faced losing their licenses. (E.g. Dr. Paul Gosselin.)

It is clear the thinly veiled agenda to remove childhood vaccine exemptions was about getting the fast-tracked experimental COVID injection into every arm.

This, along with constant fear mongering and gas lighting has resulted hundreds of Mainers losing their lives, their livelihoods, their fertility, their mental wellbeing, their community support — all of this despite

the fact that safe and effective alternatives were widely available, but heavily censored.

So, here's a bit more data from my wheelhouse to help you make the right decision to reinstate religious and philosophical exemptions to vaccines:

Pregnancy and Fertility data show:

Pfizer's clinical trial included 270 pregnant women who received the first shot.

238 were "lost to follow up." **The end result is known for only 32 of those pregnancies. Of those, 26 resulted in a miscarriage or fetal death.**

My colleague, James Thorp, MD, a maternal fetal medicine specialist in Florida and St Louis compared the flu shot in pregnant women with the Covid shot. His findings for COVID shot show:

- Abnormal uterine bleeding was 1000-fold greater
- Miscarriages were 50-fold greater
- Fetal chromosomal abnormalities were 50-fold greater
- Fetal malformations were 50-fold greater
- Fetal cystic hygroma (a major malformation) were 90-fold greater
- Fetal cardiac disorders were 40-fold greater
- Fetal arrhythmias were 50-fold greater
- Fetal cardiac arrest (heart attack in the womb) were 200-fold greater
- Fetal vascular malperfusion—100 fold greater
- Fetal grown abnormalities—40 fold greater
- Fetal placenta thrombosis —70 folks greater.

We gathered a data base of 6,000 women who reported experiencing bleeding problems and decidual cast shedding —simply from being *around* those who had had the COVID shot.

We are about to publish a paper showing that 71% of women who had not had ANY evidence of contact with COVID started to have abnormal bleeding within 3 days of being around a recently inoculated person.

The data is all on the website.

But this is just the tip of the iceberg.

Pfizer's own internal documents show that the COVID shot—which members of this legislature mandated—is the deadliest injection ever rolled out in this history of medicine. **In the first 12 weeks, there were 100 deaths per week.**

VAERS reporting, actuarial data, and government data all indicate **that estimates of 20 million deaths and 2 billion serious adverse events are likely.**

Beyond COVID Shots:

It is well documented that **unvaccinated children are far healthier** than those who undergo the now 79 total shots by age 18 "recommended" by the CDC.

Studies show unvaccinated children do not put others at risk. However, a vaccinated child/person can shed a live virus for up to 7 weeks after injection, putting many others at risk.

Vaccines contain ingredients known to be extremely toxic, including mercury, aluminum, sorbitol, and others. These ingredients have been shown to cause developmental delays; adverse neurologic events and disorders, such as motor weakness and slowing; and a host of other ill effects.

Closing:

According to attorney Shawn Rice from StandFirmNow.org, "It is a maxim of law that 'external actions indicate internal intentions.'"

The action of mandating vaccines without exemptions is not about the health and safety of our children or the broader community. It can't be because ALL vaccines carry the risk of injury and even death.

So what is the intent behind mandating vaccines without exemptions, especially one that is known to be killing and injuring people? It certainly appears that the intent is to harm or to kill. This is essentially legislating murder. It is not possible to legislate murder and grant yourselves immunity.
