As a concerned resident in Lewiston Maine and advocate for renewable energy, I believe that this project has the potential to provide significant benefits to our community and our environment.

For example, populations including older adults, children, low-income communities, and some communities of color are often disproportionately affected by, and less resilient to, the health impacts of climate change. Adaptation and mitigation policies and programs help...etc" individuals, communities, and states prepare for the risks of a changing climate and reduce the number of injuries, illnesses, and deaths from climate-related health outcomes.*
