LD 1619 An Act to Improve Maine's Reproductive Privacy Laws

Senator Carney, Representative Moonen, and members of the Maine Committee on Judiciary, My name is Abigail Beal of Cherryfield, Maine. Thank you for the opportunity to testify today.

I am here to urge you to oppose LD 1619. As you know, this law would allow abortion on demand for any reason up to the very moment of birth *and* would remove penalties for those who perform abortions without a license. So in essence, this bill is about whether or not to legalize the free murder of babies. This is the most weighty and crucial of topics. For if we cannot have life, we do not have anything.

Unborn babies *are* human beings. At 6 weeks of development, eyes are visible and teeth are forming. Gender can be learned as early as 10 weeks. At 20 weeks, they can feel pain. And at 24 weeks, they can hiccup and smile. Truly, "A person is a person no matter how small." (Dr. Suess)

We must not. I say again — we must not! Choose you this day who you will serve. Will you serve the gods of evil, death, and destruction, or will you cross the line and serve the God of life, of love, and of hope? I urge you — CHOOSE LIFE and cast in your lot with right no matter the cost.

As for me, I am absolutely unwilling for my hands to be defiled with blood. I have been charged by God with defending the poor, the innocent, and the helpless, and I am here to say, "Not here. Not on our watch!" These victims are not just "fetuses". These are babies. These are lives. Where is the future of our civilization, if not in the lives we are destroying? Where is the future of America if not in the Ten Commandments we are shunning? And where is the future of our country if not in the freedoms and Constitutions we are trampling? It is time to draw a line in the sand and defend the existence of future citizens of our state.
