# LD 1964, An Act to Implement the Recommendations of the Commission to Develop a Paid Family and Medical Leave Benefits Program

Senator Tipping, Representative Roeder, and Committee Members -

Unum is the nation's leading disability insurance company, proudly operating in Maine since our foundation here 175 years ago. Unum employs approximately 2,300 Mainers and serves nearly 45 million individuals through our various financial protection products and services.

Last year, Unum protected over 450,000 Mainers and paid over \$125 million in benefits to Maine people, including short-term disability benefits, also known as paid medical leave. In recent years, as many states enacted Paid Family and Medical Leave programs, Unum and other insurance carriers established meaningful public-private partnerships that ease the financial and administrative burden for state government but also provide flexibility and choice for employers. Many of those employers, especially here in our home state of Maine, are our customers.

In states with highly successful programs such as Massachusetts and New York, Unum built new PFML products to satisfy the minimum requirements of state programs. These plans are substantially equivalent to the state plan, allowing employers to maintain their longstanding relationships with their benefits providers while ensuring that employees receive full PFML benefits. By leveraging the existing benefits infrastructure, employees are offered a wide array of workplace benefits and can take advantage of industry expertise in claims management, customer service, return to work services, behavioral health solutions, and more.

We are encouraged that LD 1964 recognizes the vital role of private insurance in the successful implementation of any statutory PFML program. A robust role for private insurance allows the state to focus its efforts and resources on the workers who need it most, without assuming the burden of benefits already being provided by many Maine employers today.

The PFML landscape nationwide is evolving into a patchwork of various program structures, and the compliance burden is increasingly complex. That's why leveraging the expertise of the private sector can make the difference for states considering similar programs. Disability insurers manage this complexity daily through insurance products and administrative services. In fact, Unum helps over 900 companies manage more than 100 leave laws across the country.
