Good morning, Senator Carney, Representative Moonen, and distinguished members of the Joint Standing Committee on Judiciary:

I am State Representative Scott Wynn Cyrway, and I proudly represent District 63, which includes Albion, Freedom, Unity Township, and a portion of Winslow. It is an honor to appear before you for the purpose of speaking against of L.D. 780, "RESOLUTION, Proposing an Amendment to the Constitution of Maine to Protect Personal Reproductive Autonomy."

Mother Theresa once said, "How can there be too many children? That is like saying there are too many flowers." I have been involved in these life and death discussion for many years. I have seen us progress from a time when abortion was supposed to be few and safe.
