I am writing this testimony in favor of removing the Universal Cannabis Symbol from each individual piece of edible. What does this symbol actually do? It actually restricts any more products on the market. The stamp required on each individual piece is asinine. All this does is restrict what can be on the market. We were denied to put our Fruit Chews on the market due to the symbol on the fruit chews not being up to OCP standards after we were told that they would be good to go during a previous courtesy inspection.

But what really upsets me is how OCP will not enforce this on any of the products on the market. I have personally ghost shopped at Adult Use stores for gummies and nobody is following this OCP policy especially the Corporate Cannabis Companies. I believe you have seen or will see the picture that was taken. We all know these Cannabis Corporations have a hand in the pockets or have some type of major influence at OCP. Why isn't OCP going after the likes of Wellness Company. Oh I know why because Wellness will fight them in court and drain OCP of all their money. So they decide to flex their Ex-Police Officer muscle and harass the little guys while leaving the big guys alone.

The Ex-police officer thing is also something that needs to be addressed.
