My name is Thomas Wood. I am a lifelong resident of Maine and currently live on Hartford Street in Lewiston, Maine. I am testifying in opposition to LD 227. I was born in the late 1950's and grew up in Maine. I have spent virtually my whole life in this state. I was educated in Maine, and have worked and paid taxes in Maine my entire adult life. I would think that most Mainers are familiar with the state motto, "Dirigo" translated from the Latin as "I Lead". I used to have a very positive view of our state, and its motto. Now, I believe, like many in this state, I question where are we leading. I believe that this state has become a leading proponent of positions that I do not agree with. I also believe that I speak for hundreds of thousands of Mainers who don't agree with the narrow liberal agenda that has overtaken the political affairs here in Augusta. Why is this public hearing is being held on such short notice? I found out about this bill about 24 hours ago. I believe this attempt to hold a public hearing in this manner is evidence that even the Democratic leadership does not really want the public to "weigh in" on this extremely egregious bill.
