Dear Governor Mills, Senator King, Senator Jackson and Senator Vitelli,

We write to you today as concerned citizens, heart-broken by the recent mass shooting in Lewiston. We desperately want to improve the safety of our surroundings for ourselves and most importantly our children.

We recognize the complexity of the issues at hand and deeply respect the traditions in Maine. We are grateful for your commitment and dedication to assessing what is best for our beautiful state. We write to you specifically because we are hopeful that you have begun to question our lack of gun safety laws. We hope that learning of our community's feelings will help bolster your strength and interest in putting more common-sense gun laws in place now that the unthinkable has happened in Maine.

This is what we request:

- 1) Ban Assault weapons**
- 2) Institute a mandatory background check before purchasing a gun**
- 3) Institute a 72-hour waiting period after purchasing a gun**
- 4) Ban rapid-fire modification devices**
- 5) Implement a red flag law**

Here is why we know taking these steps will make us safer:

Assault weapons are designed for rapid fire and combat use; they have no place in civilian hands. According to the Giffords Law Center to Prevent Gun Violence, while the federal assault weapons ban was in place mass shootings were 70% less likely to occur. As the Lewiston shooting was conducted with an assault rifle, leaving 18 people dead and 13 wounded, it is obvious that a ban on these weapons of war would go far in preventing the next such tragedy.

Red flag laws allow family members or law enforcement officials who notice warning signs to seek court orders temporarily preventing individuals from accessing firearms. Our yellow flag law requires a psychiatric evaluation before a judge can be asked to put through a court order. This creates more red tape and more time in which a person who is a risk to themselves or others can carry out a shooting. A study from UC Davis showed that the red flag law was effectively used in 58 cases of individuals threatening mass shootings in California in the last three years. Had a red flag law been in place in Maine, rather than our yellow flag law, the police would have had the legal tools they needed to remove Robert Card's weapons from his home.

Background checks can prevent guns from falling into the wrong hands. The FBI reported through the freedom of information act that in 2020 the background check system in place for gun sales blocked over 300,000 illegal gun sales. Together with the red flag law, a comprehensive background check law would make sure that someone with Robert Card's history would neither be able to keep the guns in his possession nor gain new ones, making Maine much safer from the next would-be shooter in crisis.

A waiting period allows crucial time for impulsive buyers or those intending harm to reconsider their decisions, gain psychiatric help if needed or be intercepted by law enforcement. Behavioral economics and psychology suggest this is an effective practice due to the intensity of the impulse to hurt oneself or others is often transient. Harvard Business School found that waiting periods could reduce gun homicides by roughly 17%. As nearly 90% of Maine's gun deaths are suicides, a waiting period is likely to significantly reduce Maine's overall suicide rate and overall gun deaths. It would also decrease our veteran suicide rate, which is nearly double our overall suicide rate.

Rapid-fire modifications increase a firearm's rate of fire which can lead to disastrous consequences as seen in the Las Vegas shooting where such a device was used resulting in 58 deaths. We do not need rapid fire modifications in civilian guns. It creates more opportunity for mass death without any benefits to the gun owner themselves.

We beg you with all the fear and sadness in our hearts to implement these changes immediately. Studying what happened in Lewiston is an important step; waiting until that study is done to implement the changes above is not reasonable when there is this much evidence already available. If these laws had been in place the devastation of the Lewiston mass shooting could have been avoided. Each one of these laws would have stripped Robert Card's ability to carry out his mass shooting and yet not one of these laws is in place today in Maine.

How can we continue to improve, create and innovate without a basic sense of safety? We do not feel safe right now. There are so many things we have such little control over, but this is not one of them. Please put these laws into effect now to protect our communities and our children.
