Thank you Madam Chairman, and committee members for holding this hearing today on LD-15.

My name is Dana Lampron, from Standish Maine

I'm here today in support of LD-15. If I could take a minute to give you some reasons and comparisons to show you how unequitable and how egregious the tax treatment is on families who own camper trailers in the State of Maine.

Checking with surrounding states, Mass and Conn for example, confirmed my thoughts. Their camper trailers are taxed at the same rate as any other trailer on the road. Anywhere from \$45.00 to \$65.00 a year, unlike Maine that excise tax camper trailers the same as vehicles. So I did a little digging, you had 13,800 families who registered and subsidized the motor homes and commercial vehicles in the state last year. And you had 82,800 commercial vehicles, over 26,000 pounds registered last year, getting a huge carve out on excise tax. You may be asking what does motor homes and commercial vehicles have to do with camper trailers. So here it is....in my case, we're talking about the registration of an F350 dually that has an MSRP of \$102,000.00 which I purchased for \$93,000.00, excise tax on the full MSRP was \$2636.00, to haul a GVW of 23,000 pounds. But they exclude my camper trailer from that. My camper trailer's excise tax was based on full MSRP equaling \$3840.00, which was almost double what I paid for it. For a total of \$6476.00.

So now let's compare, motor homes get the same carve out as commercial vehicles. A new 40' Coachman Class A Motorhome, MSRP \$329,700.00, purchase price \$200,000.00, has an excise tax of \$4800.00, based on purchase price. Retail excise would be \$7912.00. Which equals \$3112.00 difference of carve outs because it's based on purchase price. Something camper trailers do not get.

Now a commercial vehicle example, a brand new 18 wheeler Peterbilt with an MSRP of \$265,000.00, purchase price \$160,000.00 has an excise tax of \$5074.00 to haul up to 100,000 pounds, now remember, that's based on purchase price. 2024 Tiffin Class A motorhome weighs 41,000 pounds, MSRP is \$666,000.00, purchase price \$478,000.00, excise tax But if you treated that tractor like the families are being treated on excise tax, that would equal \$7594.00 for 100,000 pounds. That's exactly a \$2520.00 carve out you're giving to every tractor trailer and motor home with a GVW of 100,000 pounds on your highways. And I'd like to remind you that all of the people hauling with 18 wheelers are commercial vehicles that are hauling for profit on our roads beating them to death with that kind of weight, for example, a brand new 12,000 gallon Heil gasoline hauler is about \$350,000.00 MSRP that can be purchased for around \$275,000.00, he also pays

\$45.00/year for that trailer. Now if excise tax is in place to repair and maintain roads, how in the world is this equitable or fair? Just to be clear, I am not asking this committee or anybody else for a carve out, a give me, a free be, or any kind of special deal, I'm just asking for equality and fairness.

My truck and trailer are hauling quarter of the weight that the tractor trailer is hauling. I might travel 4-500 miles a year in this state with the trailer. I'm a grandfather of 5 who likes to go camping with my grandkids. There's not a single other trailer on the road, whether it be boat, snowmobile, 4 wheelers, all of which are used for the same purpose, recreation with your families. So WHY are we discouraging and ultimately penalizing families this way? Just to put a bow on it, the town has told me on a couple of occasions the reason that camper trailers are treated this way is because they have sleeping quarters in them.

How about a 36' Boston Whaler with full sleeping quarters, bathroom, that weighs 17000 pounds, 5000 pounds more then my camper, that has to towed on the road to get to the water, has a retail price from 1.2 – 1.4 million dollars, it only costs \$200.00 to register the boat plus \$45.00 for the trailer. The point I'm making here is you're unfairly taxing the camping sector. But as I can show you and have showed you, there's all sorts of recreational activity that cost a lot more then camping but the camping people are subsidizing all the other activities with the egregious tax.

I'm paying \$282.00 per 1000 pounds, 18 wheelers are paying \$51.00 per 1000 pounds. So I'm paying 5½ times what they're paying, does that seem fair and equitable to you? I could go on and on with a lot more detail but I know my time is limited. I'd like to answer any questions you may have.

I was told if you pass LD-15 you would probably have to replace the lost revenue to the towns. I have a perfect solution for that. Last year Maine collected 3.2 M in revenue from 13,800 camper trailers. Maine also had 82,800 commercial vehicles over 26,000 pounds getting all of the carve outs I mentioned in my graph. So getting rid of some, not all, of the carve outs from commercial vehicles, like \$40.00 per vehicle, would get you your 3.2 M revenue back to the towns. That would be a step in the right direction in getting your foot off the neck of the families who like to simply camp with their kids and grandkids, and be treated with equality as everybody else in the world of recreation.
