### MOTION:

The Governor of Maine (Janet Mills) and the Director of Maine CPS (Bobbie Johnson), are guilty of violating the United States Constitution; including the Bill of Rights.

The Plaintiff and his children have been unjustly separated. The use of parenting alienation, non-verified hearsay accusations, and the use of Maine CPS at the Direction of the Governor is without question an attack on the parents and children in the United States. This includes conspiracy by using local law enforcement, mental health care fraud, and the office of Maine CPS to carry out these attacks. The Plaintiff's children; have been kidnapped by the Governor of Maine in her official capacity using the director of Maine CPS to carry out this atrocious criminal action against the Plaintiff. (exhibit #1). These actions have been reported to Lisbon Falls Police Department, Lisbon Maine on 02/20/2025, with the response of "I don't have time for your children" during the reporting of the crime to State employee Jim Goss. Currently these Constitutionally protected children are being abused and groomed for CHILD TRAFFICKING. The Plaintiff is asking for Immediate Assistance for the return of his children who are guaranteed protection under the protection of the 4<sup>th</sup> and 14<sup>th</sup> Constitutional Rights.

### United States Constitution Criminal Code

18 U.S.C. § 2381: Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or imprisoned and fined, and incapable of holding any U.S. office. No Person shall be convicted of Treason unless on the testimony of two Witnesses to the same overt Act, or on Confession in open Court.

### RELIEF REQUESTED BY THE COURTS OF THE UNITED STATES DISTRICT OF MAINE

Immediate action procuring the release of all children held by the State of Maine to their parents who fit the required criteria for Constitutionally Protected Rights that have been violated by the 4<sup>th</sup> and 14<sup>th</sup> amendments. The crime of TREASON WILL BE PROVEN AGAINST ACTORS OF STATE GOVERNMENT, who have been complacent in this action.

### JURISDICTION:

The United States District of Maine has original jurisdiction over cases filed within its jurisdiction. These cases can include civil and criminal matters that fall under federal law.

The jurisdiction of the District of Maine consists of all the counties in the state of Maine.
