Senator Ingwersen and Representative Meyer and distinguished members of the Maine Health and Human Services Committee my name is Mike McClellan. I am the Executive Director of Maine Right To Life, an organization that was established to honor the dignity and inherent value of every human life. I am here to testify against LD 143: An Act to Improve Women's Health and Economic Security by Funding Family Planning Services, sponsored by Sen. Teresa Pierce of Cumberland.

I am a former Maine Legislator and so I both appreciate and thank you each for your service. I start simply pointing out the folly of a notion that while we are here discussing government funded death of babies, it is possible that in another room in this building there is a discussion going on about Maine losing young adults who chose to leave the state or Maine not having enough people for the coming years.

As a former Maine Legislator (125th - 127th) I sat in seats like yours as we argued the traditional 2-party arguments about issues such as taxes, unions and paying for healthcare. As I look at the current state of the State of Maine, I find it incredible that you are even considering this legislation. It is not hard to see issues like workforce, education, infrastructure, the budget, our aging population, homelessness, all issues that should be a focus.

The Maine Development Foundation "Measures of Growth" 2024 edition was created, I believe in part, to give you guidance. The Measures of Growth look at about 25 indicators that tell us how Maine's economy is doing. Since some of you may have missed this, here are a few highlights: RED FLAGS - Labor Force, 4th Grade Reading, 8th Grade Math, Cost of Energy, Housing Availability and Mental/Behavioral Health. Our crime rate rose 6% even as we are viewed as one of the safest states. That is a lot to focus on. True, most of these issues are not with your committee but you each also participate as a member of the entire Maine Legislature. LD 143 is asking for two appropriations of about \$6,000,000 each to be given to one entity. Hmm... Planned Parenthood announced last summer (I believe), they were going to be down \$8,000,000 over the next few years. Should I assume this is what we are discussing with LD 143?
