## Judicial Branch testimony in favor of LD 779, An Act to Fund the Aroostook County Drug Treatment Court and LD 753, An Act to Support an Aroostook Adult Treatment and Recovery Court:

Senator Carney, Representative Kuhn, members of the Joint Standing Committee on Judiciary, my name is Julie Finn and I represent the Judicial Branch. I would like to present testimony and information in support of LD 779 and LD 753, in that both bills support establishing a Treatment Court in Aroostook County.

There is a fairly long history of efforts to create a Treatment Court in Aroostook County. In response to a bill sponsored by former Senate President Troy Jackson, the first stakeholders meeting convened to discuss the feasibility of adding a Treatment Court in the County was held on May 17, 2023, nearly two years ago. Two weeks later, the group met and began work on the Judicial Branch application. This application form was developed by the Judicial Branch to provide guidance and formalization for the development of new Treatment Courts. See Administrative Order, JB-16-01. The stakeholders group continued to meet through the summer and fall of 2023, until the application was ready for submission on February 22, 2024. After the Trial Chiefs and other Judicial Branch staff reviewed the application, the following message was relayed to the stakeholders:

---

*... we can offer a provisional approval of the application. In order to gain full approval, the Judicial Branch is requesting detailed information regarding the sources of funding for the various stakeholders. Specifically, you all may intend for the costs outlined in the application to come from a legislative bill with fiscal note, grants, donations, pre-existing employee efforts, or other sources. To ensure transparency about financial expectations, those details are necessary for us to proceed further in our approval.*

Many individuals have committed a great deal of time to the discussions around creating a Treatment Court in Aroostook County. The need for it has been demonstrated and not been questioned. The only thing that remains is identifying the funding.

The Judicial Branch thus supports the initiation of this court and does not require financial resources for it. We ask the Committee and the Legislature to consider funding the entities listed in LD 779. One item that the Legislature should consider adding to the bill is funding for the new team in Aroostook County to receive training. There are national standards and protocols to which all of our specialty courts adhere. Our other specialty court teams have received the training and it is considered a best practice to do so.

To the extent that LD 753 directs funding to the Judicial Branch, we are opposed to that aspect of the bill.
