LD 1092, An Act to Ensure that Dual Distribution Prohibitions Are Not Violated by Direct Shippers of Wine

Good morning, Sen. Hickman, Rep. Supica and members of the VLA committee. I am Cheryl Timberlake, a resident of Mt. Vernon. I serve as the Executive Vice President of the Maine Beverage Distributors Association (MBDA).

As family-owned businesses who have been in operation since Prohibition, MBDA remains committed to championing a smartly regulated alcohol distribution system where suppliers, wholesalers, and retailers maintain their distinct roles and independence. MBDA is in strong support of LD 1092.

I want to thank the sponsors Rep. Chapman, Boyer and Hymes. As noted in the opening remarks, this bill remedies a conflict in statute regarding the direct sale by a winery to a Maine consumer in a territory exclusively assigned to a Maine distributor

Maine Revised Statute Section 1403-A permits Certificate of Approval Holders (COA) to directly ship wine to Maine consumers subject to certain limitations.

Title 28-A Chapter 57 provides specific licensing requirements for wine wholesalers and COAs. Section 1453 which prohibits dual distribution.

When a winery enters a relationship with a Maine wholesaler, they execute a distribution agreement, which includes designation of a sales territory and the list of products the wholesaler is authorized to distribute. All distribution agreements embody exclusive territory assignments. The winery, COA, files the application with BABLO.

If a "direct shipper" sells wine to a consumer located in a territory assigned to a Maine wine distributor, that sale would violate the prohibition on dual distribution provided in Maine Revised Statutes § 1453.

MBDA is concerned that wineries may sell into a distributor's territory and thereby violate § 1453 and breach their distribution agreements.

To avoid violation of the dual distribution statute and the exclusive territory provision in distribution agreements, this bill will restrict the wine direct shipper permit to those wineries that have not entered into a distribution agreement with any Maine wine distributors.

Distributors build wine brands, invest in their inventory, provide retailer education and expertise. MBDA wants to ensure accounts have the portfolio of products to their customers' desire. Our members service over 1000 retail wine accounts throughout the state. These licensees provide more than 12,000 unique wine SKUs for customers.

The attached list of DTC permits represents the last 60 days of license renewal/activity. There are several large manufacturers identified which have distributor representation. What is unknown from this report is whether these wineries have a DTC permit for wine varieties distinct from those wines included in the distribution agreement.

This issue was brought to our attention by a local winery who has a DTC permit and an assigned distributor. During our discussion we came to understand that the permit process may differentiate the label declarations as to how the wine DTC shipper intends to sell the wine, self- distribution or distributor assignment.

This is a distinction that is not clarified in the current bill draft.

WINE DUAL DISTRIBUTION ANALYSIS:

A winery which does not have an exclusive distribution agreement with a Maine distributor can ship directly to a Maine consumer with a permit. But a winery which already has an exclusive distribution agreement with a Maine distributor does not need the privilege of selling direct to a consumer, nor does a Maine consumer within such territory need to be able to purchase direct from the winery because the wine is available through local retailers.

If a "direct shipper" sells wine to a consumer located in a territory assigned to a Maine wine distributor, that sale would violate the prohibition on dual distribution embodied in Maine Revised Statute § 1453.

The direct sale by a winery to a Maine consumer in a territory exclusively assigned to a Maine distributor would constitute a breach of the distribution agreement.

§1453. Dual distributorship prohibited

1. Dual distributorship prohibited. A certificate of approval holder that designates a sales territory for which a wholesale licensee is primarily responsible may not enter into any agreement with any other wholesale licensee for the purpose of establishing an additional agreement for its brand or label in the same territory.

2. Certificate of approval holder to file list. Each certificate of approval holder shall file with its application for a certificate of approval or in-state manufacturer license a list giving the name and address of each bottler and wholesale licensee authorized to distribute products of that certificate of approval holder and designating the exclusive territory assigned to each wholesale licensee within the State. Unless authorized by the bureau, wholesale licensees may not sell those products to licensees outside of the exclusive territory allocated and designated.

A. Sales of wine to retail licensees at the wholesale licensee's warehouse must be considered a sale within the wholesale licensee's exclusive territory. [PL 2021, c. 658, §256 (AMD).]

3. Primary source of supply. A wholesale licensee may not purchase liquor from anyone other than the primary source of supply within the United States.
